- I am, accordingly, directed to convey the sanction of the President of India to release a sum 2. of Rs. 6,60,000/- (Rs. six lakh and sixty thousand only) as a balance amount (17.68-11.08) of the first installment as against the cost of the proposal amount of Rs. 35,36000/- subject to the condition that the balance of 50% of the approved proposals will be released within one year of the release of first installment during which period the 25% share of the minority institutions, should be contributed to the infrastructure upgradation. Release of 2nd instalment of central assistance would, however, be subject to furnishing of UCs along with the audited expenditure certificate.
- It may be ensured that grants being released here be utilized only for the purpose for which it has been approved in a time bound manner.

As the proposals are to be implemented through the state Government it is the responsibility of the State Government for ensuring proper utilization of Government funds subject ty lastitutes (IDAI) actu to the following conditions:-

The State Government is to ensure utilization of released funds expeditiously in i) accordance with the norms of the scheme and as per approved proposals within one year after the receipt of the 1st installment.

The proposal of 2nd installment after utilization of 75% of the available funds should be ii) submitted within a period of one year after the receipt of 1st installment.

A copy of every order of the State Government according administrative approval of iii) financial sanction for any item of non-recurring or recurring expenditure (including order concerning posts) in connection with the above project will be endorsed to this Department.

The State Government will submit a quarterly progress report along with audited iv) expenditure certificate.

- The expenditure involved is debitable to Demand No.59-Department of School Education and Literacy - Major Head '3601 Grants -in- Aid to State Government 02- Grants for State Plan Scheme, 165- Elementary Education. The Scheme for Providing Quality Education in Madarsas / Minorities 01.00.35- Grants for creation of Capital asset (Plan) 2014-15.
- On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to 5. Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and finance Department of State Government concerned along with a copy to the undersigned.
- This issues in exercise of the delegated powers in consultation with the Integrated Finance Division's vide their Dy. No. 554/2015-IFD dated 30.03.2015 and Finance Branch vide their Dy. No. 1729/2015-IF-II dated 31.3.2015.
