- 2. In continuation of this Department's sanction letter dated 22<sup>nd</sup> February, 2016, I am directed to convey the sanction of the President of India to release a sum of Rs. 3,29,31,500/-(Rs. Three Crore Twenty Nine Lakh Thirty One Thousand and Five Hundred only) as 2<sup>nd</sup> installment to Secretary, School Education Department, Government of Chhattisgarh for implementation of the above mentioned scheme for the year 2014-15 and subject to fulfilling of all terms and conditions laid down in the scheme and in terms of this Ministry's letter dated 29.10.2008. This is also subject to the condition that the Madarsas seeking financial assistance fulfill eligibility conditions as per paras 9-13 of the Scheme and all the teachers are actually engaged during the period and possess requisite qualifications. This is a purely voluntary scheme and the concerned institution has to apply to the State Government.
- 3. The expenditure involved is debitable to Demand No.51- Department of School Education and Literacy Major Head '3601 Grants-in-Aid to State Government 02-Grants for State Plan Scheme, 165-Elementary Education-Other Grants, 02-Development of Minorities; Education Scheme for Madarsas/ Minorities, 01-Scheme for Providing education to Madarsas/Minorities; 02.01.31-Grant-in-aid General (Plan) 2016-17.
- 4. It is certified that the grant in aid is being released in accordance with the pattern of assistance approved by the Planning Commission and the Ministry as also in conformity with the rules and regulations of the Scheme.
- 5. The amount of the grant is to be utilized only for the purpose for which it was sanctioned. Accounts from the State Government to be furnished to the Central Government within one year issue of the sanction positively along with the monitoring report regarding number of Madrasas receiving assistance, total number of beneficiary students and the amounts received and utilized by the Madrasas.
- 6. On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of State Government concerned along with a copy to the undersigned.
