No. F.7-8/2009-(MC):- In pursuance of the Section 3 (2) read with Section 5 of the National Commission for Minority Educational Institutions Act, 2004, the Central Government is hereby pleased to appoint Shri Zafar Agha, C-27, Press Enclave, Saket, Delhi, as Member of National Commission for Minority Educational Institutions (NCMEI) to discharge the functions of a Member under the National Commission for Minority Educational Institutions Act, 2004.

Ordered also, that a copy of the notification be communicated to Shri Zafar Agha.




