Subject:- Special Recruitment Drive to fill up of vacancies for Persons with Disabilities (PwDs)-reg.

Sir/Madam,

I am to refer to this Ministry's letter of even number dated 12.8.2015 (copy enclosed) on the subject mentioned above and to say that in Hon'ble Supreme Court's judgement dated 08.10.2013, the Court had given to the "appropriate Government" certain directions to ensure implementation of the reservation policy for the disabled and to protect their rights, in the context of implementation of the Orders of the Hon'ble Supreme Court in the matter of Civil Appeal No. 9096 of 2003 arising out of SLP (Civil) No. 7541 of 2009 titled Union of India & Anr. Vs. National Federation of the Blind & Ors.

2. The Department of Personnel & Training (DoP&T) is presenting the issues as seen by Government and the status case in the Court of India on behalf of Government of India. On the basis of information received from various institutions/organisations, associated with it, the Ministry of HRD had intimated the status of vacancies reserved for PwDs to DoP&T.

3. DoP&T has informed that Hon'ble Supreme Court has directed that all the vacancies reserved for Persons with Disabilities (PwDs) must be filled by December, 2015 by launching 'Special Recruitment Drive' and the advertisements, issued for this purpose, must be uploaded on the websites of DoP&T, Deptt. of Empowerment of Persons with Disabilities, Office of Chief Commissioner of the PwDs and the website of the concerned Institute/organization.

4. It is requested to the Heads of all the Centrally Funded Educational Institutions/Autonomous Organizations/attached offices in the Ministry of Human Resource Development to initiate the launch of s Special Recruitment Drive to fill up the vacancies for PwDs in their Institutions/Autonomous organisations.

5. You are also requested to take immediate action to advertise the vacancies earmarked for PwDs (if any) by 26th October, 2015 positively, if not advertised till now. These vacancies must be filled up in accordance with the time frame stipulated by the Hon'ble Supreme Court i.e. by December, 2015. It may also be ensured that the advertisements are uploaded on the websites of DOP&T, Deptt. of Empowerment of Persons with Disabilities, Office of Chief Commissioner of the PwDs.

5. This may be treated as urgent and a report in this regard, may be sent to this Ministry, by **30th October, 2015** positively.
