It is important that all applications meet the established deadline, thus all care should be taken to ensure that such candidatures reach the Bureau of Human Resources Management prior to the closing date. Applications received after the stipulated deadline cannot be considered.

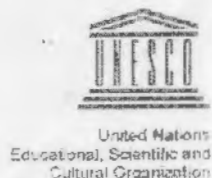

OVERVIEW OF THE FUNCTIONS OF THE POST

UNESCO is seeking the appointment of a renowned scientific leader and administrator to serve as Executive Director of The World Academy of Sciences for the advancement of science in developing countries (TWAS). UNESCO promotes international cooperation in science in the interests of peace and sustainable development.

The main objectives of the Academy are to: (i) recognize, support and promote excellence in scientific research in the South; (ii) provide promising scientists in the South with the research facilities necessary for the advancement of their work; (iii) facilitate contacts between individual scientists and institutions in the South; (iv) encourage North-South and South-South cooperation between individuals and centres of scholarship; and (v) promote scientific research on major challenges faced by developing countries.

TWAS is also responsible for the administration of the following organizations hosted by the Academy: The Organization for Women in Science for the Developing World (OWSD) and the Inter-Academy Partnership bringing together renowned networks of academies of science and medicine.

Under the overall authority of the Assistant Director-General for Natural Sciences and the guidance of the TWAS Steering Committee and the TWAS Council as regards the programmatic direction, the incumbent will be responsible for providing intellectual, strategic and operational leadership in the development, management, planning and execution of TWAS international scientific cooperation programmes. This includes the coordination of the work of TWAS with the associated organizations, the development of innovative approaches to promote South-South cooperation in the area of the basic sciences and the development of new networks in applied sciences with leading international organizations in view to promote scientific excellence for sustainable development in the South.

In particular, and in line with the Organization's policies and procedures, including effective internal controls, the incumbent will supervise the work of the TWAS staff and prepare action plans, annual programmes, budgets and reports to donors. He/She will provide strategic leadership for resource mobilization and also act as Secretary to the meetings of the TWAS Steering Committee.

REQUIRED QUALIFICATIONS

EDUCATION

- Advanced University Degree (Master's degree or equivalent degree) in one of the fields of the natural sciences. A first-level university degree in combination with at least two additional years of qualifying experience may be accepted in lieu of the advanced university degree.

WORK EXPERIENCE

- A minimum of 15 years of leadership experience in scientific research and administration, including extended experience in international organizations.
- Recognized leadership experience in a leading scientific and administrative position, with experience in human resources and finance management.

UNESCO is committed to promoting geographical distribution and gender equality within its Secretariat. Therefore, women candidates are strongly encouraged to apply, as are nationals from non- and under-represented Member States. Persons with disabilities equally are encouraged to apply. Worldwide mobility is required as staff members have to serve in other duty stations in accordance with UNESCO's geographical mobility policy.

- Successful experience in fund-raising from governments and the private sector, and international funding and technical assistance organizations and agencies.
- Good understanding of science, technology and innovation needs of developing countries.

- Institutional leadership capacity, high sense of objectivity and professional integrity, diplomacy, tact and political astuteness.
- Strategic planning and management abilities, including capacity to administer extensive programmes, financial resources and exercise appropriate supervision and control.
- Ability to take initiative and maintain effective working relationships with people of different nationalities and cultural backgrounds.
- Capacity to provide intellectual leadership to guide staff and motivate teams in a multicultural environment.
- Ability to communicate effectively and persuasively, orally and in writing, with strong representational abilities.
- Organizational skills, including in establishing plans and priorities, as well as implementing activities effectively.

LANGUAGES

- Excellent knowledge and drafting skills in one of the working languages (English or French) of the Organization and a good knowledge of the second one. Training will be mandatory in order to acquire the required level of the second working language in a reasonable time-frame.

- Ph.D. in one of the fields of the natural sciences.
- Other degrees or short- to medium-term training in disciplines relevant to the post.

WORK EXPERIENCE

- Experience in the field of international relations and diplomacy, multilateral cooperation, development.
- Experience in conducting policy dialogue at government and non-government levels or public and private sectors.
- Experience in research work and/or teaching at university or in a research institution.
- Broad knowledge of environmental problems, with field experience.
