Applications are invited for appointment to the post of Director of six new Indian Institutes of Technology (IITs), at Tirupati (AP), Palakkad (Kerala), Jammu (J&K), Bhilai-Durg (Chhattisgarh), Goa and Dharwad (Karnataka). The Director of an IIT is the academic and administrative head of the Institution. He/She is expected to have adequate (a minimum of 5 years) administrative, teaching and research (including significant experience in research guidance at the Ph.D. level) and leadership qualities to head an Institute of National Importance. The candidate/person should be a Ph.D. with first class or equivalent at the preceding degree preferably in a branch of Engineering. In exceptional cases candidates with Science, Mathematics or Management degrees may be considered. He/she should have an outstanding academic record throughout and a minimum of 10 years experience as a Professor in a reputed Engineering or Technology Institute or University. The applicant should not be more than 60 years of age on the last date of receipt of applications. The post carries a fixed pay of Rs. 80,000/- (Apex scale) per month, with allowances as per rules.

- 2. The IITs at Tirupati, Palakkad, Jammu, Bhilai-Durg, Goa and Dharwad are autonomous institutions fully funded by the Ministry of Human Resource Development. The Director of each of the above IITs will be appointed after obtaining the approval of the Competent Authority based on the recommendations made by the Search-cum-Selection Committee which will consider applications received in response to this advertisement, as well as nominations received from eminent persons. The appointment will be on a contractual basis for a period of five years or till the attainment of 70 years, whichever is earlier, as per usual terms and conditions.
