
2. **AGE:** The candidate applying for the post should preferably be below 60 years of age at the time of applying.

In addition, the candidate shall be an eminent person in his / her field of specialization with an outstanding academic record throughout. The candidate shall have 15 years experience in Teaching / Industry / Research out of which 10 years must be at the level of Professor or above in a reputed educational Institute, Industry / Research Organisations.
