- (d) Publication in journals, especially in journal of education of national and international repute; and
- (e) Administrative, organizational and leadership capabilities besides wide ranging interest in regard to conduct of research on different aspect of school education.

- (ii) Age Candidate shall not be more than 57 years old as on the last date of receipt of application. However in case of exceptionally qualified candidates, this may be relaxed.
