Officers under Central or State Governments or Union Territories or Universities or recognized Research Institutions or Public Sector Undertakings or semi Government or autonomous or statutory organizations :-

- (a)(i) holding analogous post on regular basis in the parent cadre or department; or
- ii) with two years' service in the grade rendered after appointment thereto on a regular basis in the pay band-2, Rs.9300-34800/- with grade pay of Rs.4800 or equivalent in the parent cadre or department; or
- iii) with three years' service in the grade rendered after appointment thereto on a regular basis in the pay band-2, Rs.9300-34800/- with grade pay of Rs.4600 or equivalent in the parent cadre or department; and

(b) possessing the following educational qualifications and experience:-

- (i)Master's degree from a recognised University with English Literature as one of the subject at the degree level;
- (ii)one year experience in preparation and production of publication including printing of material particularly relating to education journals or reports or monographs in any Government department or Public Sector Undertakings or recognized research institutions or autonomous or statutory organizations.

Note:1 Officers of only Central or State Governments or Union territories shall be eligible for consideration for appointment on absorption basis.

Note:2 Period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years.The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding fifty six years as on the closing date of the receipt of applications.

Note 3: For purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extended only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation .
