NOTICE INVITING APPLICATIONS FOR APPOINTMENT OF THE FIRST VICE CHANCELLOR OF MAHATMA GANDHI CENTRAL UNIVERSLITY TO BE ESTABLISHED IN BIHAR

The Central Universities (Amendment) Act 2014 for establishment of Mahatma Gandhi Central University with territory jurisdiction in the north of River Ganges in the State of Bihar has been assented to by the President. The first Vice Chancellor shall be appointed by the Visitor of the University, for such term, not exceeding five years, as may be specified by the Visitor.

The post carries a pay of Rs. 75,000/- (Fixed) per month with Special Allowance of Rs. 5000/- and other usual allowances.

The Vice-Chancellor, being the academic as well as administrative head, is expected to be:

- A visionary with proven leadership qualities, administrative capabilities as well as teaching and research credentials.
- Having outstanding academic record throughout and a minimum of ten years' experience as a Professor in a University system or ten years' of experience in an equivalent position in a reputed research and/or academic administrative organisation.
- Not more than 65 years of age as on the closing date of receipt of applications of the advertisement.

Eligible individuals may send their applications by Post in the prescribed proforma, to Deputy Secretary (CU-I), Department of Higher Education, Ministry of HRD, Room No.429, 'C' Wing, Shastri Bhawan, New Delhi-110115 within 30 days of the advertisement.
