#### Appointment of Director of IIIT (PPP) Bhagalpur, Bihar

Applications are invited, for appointment to the post of Director of Indian Institute of Information Technology in Public- Private Partnership mode (IIIT-PPP), Bhagalpur.

- 2. The Director of a IIIT, being the academic as well as administrative head, is expected to have proven administrative, teaching and research background (including significant experience in research guidance at the Ph.D. level) with the leadership qualities to head an Institute of National importance. The candidate should be a Ph.D. in the appropriate branch with an outstanding academic record throughout and a minimum of 10 years experience as a Professor in a reputed Educational Institute (relaxable in case of an outstanding candidate). Applicant should preferably be not more than 60 years of age. The posts carry a fixed pay of Rs. 75,000/- plus Special Allowance of Rs. 5,000/- per month with allowances (pre-revised) as admissible under the Rules of the Institute.
- 3. The IIIT Bhagalpur is an autonomous institution established in PPP mode, with participation from the Central Government, the concerned State Government, and the Industry Partner(s). The first Director of Institute is being appointed. The Director will be appointed after obtaining the approval of the Competent Authority based on the recommendations made by the Search-cum-Selection Committee. The Search-cum-Selection Committee will consider applications received in response to this advertisement, as well as nominations received from eminent persons. The appointment will be on contractual basis for a period of five years or till the attainment of 70 years, whichever is earlier, as per usual terms and conditions.
