- A distinguished academician, with a minimum of 10 years' experience as Professor in a University or 10 years' experience in a reputed research and/or academic administrative organisation with proof of having demonstrated academic leadership.
- Preferably not more than 65 years of age as on the closing date of receipt of applications of this advertisement.

#### **Salary and Service Conditions**

- The post carries a pay of Rs. 2,10,000/- (Fixed) per month with Special Allowance of Rs. 11,250/- and other usual allowances.
- The terms and conditions of the services will be those as set forth in the Central Universities Act, 2009.

- The first Vice Chancellor shall be appointed by the Visitor (Hon'ble President of India) of the University in such manner and for such term, not exceeding five years, as may be specified by the Visitor.
