Minutes of the 15th meeting of the Project Approval Board (PAB) of Rashtriya Madhyamik Shiksha Abhiyan (RMSA) held on the 19th and 20th July, 2011in Ranchi to consider Annual Plan Proposals of <u>Orissa</u>, <u>Bihar</u>, <u>Jharkhand and Chhattisgarh</u>.

- 1. The 17th meeting of the Project Approval Board (PAB) of RMSA was held on the 19th and 20th July, 2011 in Ranchi to consider Annual Plan Proposals of Orissa, Bihar, Jharkhand and Chhattisgarh under the Chairpersonship of Smt. Anshu Vaish, Secretary, Department of School Education & Literacy, Government of India.
- 2. List of participants is at **Annexure-I**.

Secretary (SE&L) welcomed the participants and invited the State representatives to present their Annual Plan proposals 2011-12.

3. ORISSA

- 3.1 Education Secretary, Govt. of Orissa presented the overall status of secondary education in the State (**Annexure-II**) while highlighting the following:
 - State's initiative to recruit teachers for 700 new Secondary schools
 - Concrete efforts to strengthen SMDCs and reform in examinations
 - Need for aided schools to be made eligible for strengthening and other interventions under RMSA.
 - Need for enhancement in the percentage of MMER from 2% to 4%.
 - Text books and school uniforms may be allowed to be supplied to students of Class 9 and 10 from RMSA funds.
- 3.2. The State proposed opening of 42 new schools. It was observed that out of the 42 proposed, 27 were already secondary schools and 4 schools did not have Class 8 and therefore could not be upgraded to secondary schools. On appraisal only 9 schools were found eligible and PAB approved 9 new 'two-section' schools. PAB also noted that of the 300 new schools sanctioned in 2009-10, 70 are still not functional.

- 3.3 Secretary (SE&L) observed that Orissa is a State with a large tribal population and therefore the State Government needs to consult other Departments like Tribal Welfare, Social Welfare etc. also while formulating the Annual Plan proposal for RMSA, especially with a view to ensuring enrolment and retention of SC/ST children in schools.
- 3.4 After detailed deliberations, the following components/activities were approved by the PAB:
- (a) Non-recurring components (school-wise approved list at **Annexure-III**):

4. Chhattisgarh

- 4.1. Education Secretary, Govt. of Chhattisgarh presented the overall status of secondary education in the State (**Annexure -IV**) and highlighted the following:
 - The bilingual data collection format (both in Hindi and English)
 - The data collection has been made a compulsory exercise for all secondary schools.
 - Fully computerized online management system of fund disbursement and monitoring.
 - Comprehensive two tier habitation and school mapping exercise done in the State based on E-Prapatra and GIS mapping.
 - 100% achievement in terms of opening of 500 new schools sanctioned for the year 2010-11.
 - Special drive for enrolment of children in secondary schools started in 2010
 wherein one teacher from each secondary school has been nominated as
 enrolment coordinator and assigned the task of keeping track of all children
 passing out of class 8 and ensuring 100 % enrolment in the nearest secondary
 school.
 - Principals and Head masters of all Upper Primary schools and Secondary schools oriented towards their roles and functions at SMDC meetings.
 - Counseling sessions for children and parents are also held by the Head teachers' of the assigned schools.

Secretary (SE&L) appreciated the efforts of the State Govt. of Chhattisgarh and RMSA team in Chhattisgarh and felt that these initiatives taken by the Chhattisgarh team should be shared with the other States.

4.2. The State Government proposed opening of 1145 new schools in addition to 30 Madhyamik Ashram Vidyalaya. The appraisal team found that only 633 schools can be sanctioned as per norms. Further during 2010-11, PAB had approved construction of 14 porta cabins for classrooms. The State Government has now informed that the locations of these 14 porta cabins (schools) are effected by Left Wing Extremism and therefore funds are required for upgradation of these porta cabins so that residential facility could be provided for the students of these schools. The State Government was informed that, at present, there is no provision for providing funds for residential facilities along with the schools. The State Government expressed its inability to run these 14 schools if funds for residential facilities are not provided. After detailed discussions in the PAB, it was decided to revoke the approval for construction of 14 porta cabins, which were approved during 2010-11.

Secretary (SE&L) therefore suggested that this issue may be highlighted while preparing the 12th Five Year Plan.

- 4.3. With regard to the proposed 30 Madhyamik Ashram Vidyalayas in which the posts of 60 staff were also proposed to be sanctioned, it was pointed out that details of location along with the necessary financial liability has not been furnished by the State. Further, it was felt that since Ministry of Tribal Affairs also funds Ashram schools in tribal areas and Ministry of Social Justice funds Ashram schools for SC children, the State may first examine and make sure that there is no overlapping or duplication of efforts.
- 4.4 After detailed deliberations, following components/activities were approved by the PAB:

5. BIHAR

- 5.1. Secretary, School Education and SPD, RMSA Govt. of Bihar gave a brief over view of the status of Secondary Education in Bihar (**Annexure-VI**). Highlights include:
 - Initiatives like Mukhyamantri Balika Poshak Yojana, Mukhya Balika Cycle Yojna for both girls and boys of Class 9 have led to increased enrolment.
 - Manual mapping has been carried out and 1007 new secondary schools are required to cover all habitations
 - School development plans not been prepared and the State yet to carry out this
 exercise.
 - Highest student class room (SCR) ratio in the country. District Khargana with SCR of 143.73%, Vaishali 136.6% and Katihar 123.91% present the worst scenario.
 - Mapping exercise based on GIS is going on. On completion, there may be slight changes in the requirement of schools
 - Bihar Education Infrastructure Corporation entrusted with execution of civil works. Third party evaluation also provided for civil works to ensure quality of civil works.
 - Day to day monitoring of civil works to be done by Nirman Samiti constituted under SMDC. For works less than 10.00 lakh, Nirman Samiti to execute the work at their level.

- With regard to the recruitment of teachers in new secondary schools, it was informed that the process is likely to be completed by October 2011 and teachers will be in position by December 2011.
- 5.2 While discussing the GER variations across districts at secondary level, it was noted that GER for the district of Paschim Champaran is extremely low at 23.18%, Arariya at 21% and Kishan Ganj at 16%. The PAB felt that there is an urgent need for special and strategic interventions in these areas to be able to achieve even a moderate target of 45% GER at secondary level by 2012. The State also has an adverse gender parity index especially in the districts of Madhepura, Saharsa and Satwal.
- 5.3 During 2009-10 and 2010-11, 797 schools have already been sanctioned under RMSA; 210 new secondary schools are now required. Accordingly, the State Government proposed opening of 210 new secondary schools. The appraisal team reiterated the need for the State to develop a strategy for interventions focusing on equity and quality especially in the special focus and backward districts. The need for community mobilization was also underlined.

6. Jharkhand

- 6.1 The Principal Secretary (Education), Government of Jharkhand made a presentation (**Annexure-VIII**). Highlights include:
 - School mapping exercise has been conducted both at the block as well as the district level to assess the requirement of secondary schools in the State.
 - The proposal for the new schools under RMSA has been made on the basis of manual school mapping exercise through school mapping format designed by the State itself. The GIS mapping is under process.
 - Out of 1,22,021 habitations in the State, 71,379 habitations are already served by a secondary school within 5 kms; 50,642 habitations are without secondary school within the 5 kms.
 - 100% of the funds released for preparatory activity have been utilized.
 - The GER for the State at secondary level is 35 in 2009-10 and drop-out rate is more than 30%. The drop-out rate is over 80% in the district of Singbhum and Godda.

The PAB discussed the drop-out rate in Singbhum and Godda and it was felt that there is a possibility of data inconsistency. The State Govt. was requested to check the GER and drop-out rate for these districts again.

- 6.2 During 2009-10, 300 new schools were approved by PAB. However in the meeting of PAB held on 21.01.2011 for considering the proposals for 2010-11 of Jharkhand, it was observed that State Government has changed some schools from the approved list of 300 new schools. The State Government clarified that, during the course of approval from the State Government, it was found 8 schools in the list of approved schools were already upgraded as High Schools. Apart from this, the proposal submitted by the State Government did not include any school from the most naxal affected district - Latehar. Therefore 38 schools have been changed in the list of approved 300 schools. The State Government has therefore requested to approve revised list of 38 new schools. The proposal was appraised and found that 23 schools satisfy the distance and enrolment norms. Remaining 15 schools do not conform to the distance norm of 5 kms. It was informed that these schools are located in difficult terrain or forest/hilly areas. The aerial distance from the nearest school may be below 5 kms but the walking distance is around 5 kms. Accordingly, 38 schools as proposed were approved by the PAB. A revised list of 300 schools is at **Annexure-IX**.
- 6.3 On the issue of lack of suitable and qualified teachers the State Govt. submitted that there are a number of vacancies especially in Maths and Science subjects and also due to the fact that these posts are reserved for resident tribal candidates only. Hence, ad-hoc arrangements have been made with regard to the vacant posts. Secretary (SE&L) expressed her concern that the present arrangement of ad-hoc teachers will affect the quality of teaching in the schools and pointed to the need for regular qualified teachers being appointed on priority.
- 6.4 With regard to the State Government's proposal for promotion of Hockey and Archery in schools, the PAB recognized the fact that children from Jharkhand are naturally talented and gifted in the field of sports, especially in Hockey and Archery. While agreeing that sports and physical activity should be an integral part of secondary education schools, it was decided that RMSA presently cannot support these activities due to limited resources.
