### MINUTES OF THE MEETING OF THE GRANTS IN AID COMMITTEE TO CONSIDER PROPOSALS OF THE STATE GOVERNEMENTS UNDER THE GIRLS' HOSTEL SCHEME HELD ON 22.7.2010

A meeting of the Grants in Aid Committee (GIAC) for the "Scheme for construction and running of Girls' Hostel for students of secondary and higher secondary schools" was held on 22.07.2010. The meeting was chaired by Secretary, Department of School Education & Literacy. A list of participants is <u>appended</u>.

2. Joint Secretary, School Education Department, Govt. of Orissa presented the proposal of the State Government to set up 53 Girls' Hostels in the state. He mentioned that the scheme would be implemented by 'Orissa Primary Education Programme Authority' and that sufficient land (minimum being 2 acre in each of the case) is available for all hostels, and provision has been made in state budget to meet state share.

3 He clarified that all the hostels have been proposed in the premises of Government Girls' or Co-educational Schools. At least one girls' or co-educational school was available in close proximity of each hostel. It was also confirmed that Kalimela block in Malkangiri district was an EBB.

4 It was observed that while 15 hostels were recommended by the GIAC in November 2009, not a single hostel has yet been sanctioned as the building plan was still awaited from the State Government. Joint Secretary, Government of Orissa stated that the scheme of norm of Rs.42.50 lakh per hostel was inadequate to construct a good quality hostel. This has compelled the State Government to hold back the building design.

5 GIAC recommended 53 hostels (**annexed**) 'in principle' in Orissa subject to the State Government furnishing a design as per the provisions of the scheme and various guidelines issued by the Ministry from time to time.

6 The proposal of Meghalaya could not be taken up as no official of the State Government attended the meeting.

### 7. General Issues discussed:

**7.1 Building Design:** The GIAC observed that clear norms and specifications are required to be developed for the hostels. The requirement of 40 sq.ft. per inmate as specified in the scheme is a conservative requirement, and it may be desirable to provide for more living space per boarder. Such specifications may be decided keeping in view the norms of hostels supported by the Central/State Governments under various schemes.

**7.2 MMER cost :** Some of the State Governments requested for release of MMER amount for the non-recurring cost already sanctioned. The Bureau clarified that MMER cost was not sanctioned as the State Governments did not ask for it. Secretary (SE&L) advised the Bureau to release admissible MMER cost as per the

scheme norms, as is the practice under other centrally sponsored schemes like RMSA, SSA and MDM. She stated that while Ministry should indicate the activities for which MMER fund may be used and allow the states to use it as an untied fund under the stipulated guidelines. The State Governments will of course have to furnish utilization within the specified time.

**7.3 Implementing Society:** Most of the State governments have decided to implement the Model Schools and Girls' Hostel scheme through the RMSA society. While the Ministry does not have any objection to this strategy, provided a separate unit within RMSA Society looks after each of these schemes and accounts are kept separate. GIAC felt that for States having a large number of EBBs, it may not be possible for RMSA society to manage Model Schools and Girls' Hostel Schemes simultaneously. GIAC, therefore, advised such states to constitute separate dedicated societies for Girls' Hostel scheme.

The meeting ended with a vote of thanks to the chair.
