Minutes of the 34th RMSA PAB Meeting (14th Integrated RMSA PAB Meeting) held on the 13th February, 2014, for approval of Annual Work Plan & Budget 2014-15 of **Punjab** under the Centrally Sponsored Scheme of the Rashtriya Madhyamik Shiksha Abhiyan (RMSA)

1. The 34th Meeting (14th Integrated RMSA PAB) of the Project Approval Board of the RMSA to consider the Annual Work Plan & Budget 2014-15 for the State of Punjab under Rashtriya Madhyamik Shiksha Abhiyan (RMSA, including the components of ICT@ Schools, Girls' Hostels, Vocational Education and Inclusive Education for the disabled at Secondary Stage (IEDSS) was held on the 13th February, 2014, under the Chairmanship of Shri R. Bhattacharya, Secretary (School Education & Literacy).
2. The list of participants who attended the meeting is attached at **Annexure-I**.

Rashtriya Madhyamik Shiksha Abhiyan (RMSA)

3. At the outset, Secretary (SE&L) welcomed all the participants. The Joint Secretary, Ms. Radha Chauhan, briefed that PAB at the beginning of the 12th Five Year Plan (2012-13), had committed liabilities to the tune of Rs 8500 Crores, but since no new works were approved in 2012-13 and with limited approvals in the year 2013-14, the Committed liabilities have come down to the tune of Rs 4800 Crores.

4. However, the concern still remains since a number of States still have a huge backlog of Non-Recurring works which could not be started due to the fixed cost norms of the earlier approvals, and where the States have not been able to arrange for the gap-funding between the earlier approved norms and the State SoRs, and where the funds have been released to the States resulting in the situation where the States are sitting on a huge unspent balance. She informed the

PAB that this has resulted in preventing the release of funds from the Ministry on one hand, which later on may lead to surrendering of funds under the scheme, while the Scheme itself suffers from lack of funds. In light of the situation the State is requested to utilize the funds sanctioned in order for further releases as well for new approvals being considered by the PAB.

5. She noted that there is a need for the State to shift the activities of the subsumed components to the RMSA SPD. Since funds for all the subsumed components are now being released to the RMSA Implementing Society (**through the State**) all correspondence and communication will be with RMSA SPD and the Secretary including financial matters concerning all its subsumed components. Therefore , the States would do well to streamline the activities relating to ICT @ Schools, IEDSS, Vocationalization of Education and Girls' Hostel functioning into the RMSA Society and formally notify the RMSA SPD as the nodal person) anchoring all these activities.

6. She also informed the Board that in order to facilitate efficient implementation and also address issue relating to amount available to States under MMER, following provisions has been made:

(i) Release of ad-hoc recurring grant to the tune of 25% of the expenditure incurred in the previous FY by the States.

(ii) Facility of spill-over of funds relating to approvals of non-recurring grant that would provide States with the flexibility to deploy funds regardless of year of its approval (but as per norms under which they were approved).

(iii) MMER to be available as against the Annual Plan approval (**not release**).

7. Ms. Caralyn K. Deshmukh, Director School education (RMSA-I) highlighted some of the issues for consideration and guidance of the PAB:

- (i) **Quality interventions: Adoption of project based approach:** The PAB outlining the overall shift that is needed with four years of activity based interventions under the Quality head of RMSA, emphasized the need for the States to adopt a holistic project based approach to interventions wherein selected activities are put together in a manner that the outcomes and objectives that are envisaged through those interventions that are clearly defined and are measurable over a period of time

through basic indicators such as enhancement in enrolment (CWSN, Girls SC..) retention, transition, performance or reduction in drop out and so on. Each such intervention needs to be substantiated by its performance outcome which should be taken up for evaluation by the State as part of its MMER activities.

- (ii) **Quality of Inclusion in Secondary schools (CWSN under IEDSS):** Even though the IEDSS scheme has been subsumed under the RMSA, the planning and implementation of this component is still being carried out in an isolated manner, with some of the States/ UTs still implementing the interventions under this component through NGOs and not in the regular schools. The PAB stressed that Secondary Schools need to be made more inclusive for CWSN, with adaptations to infrastructure to be planned under the RMSA non-recurring / civil works component, while the teacher training for improving inclusive practices (targeted at CWSN) of Subject teachers should be within the RMSA teacher training package.

The issue of deployment of special **education teachers** was highlighted that at present, there is no deployment policy of special education teachers in any state and their (special education teachers) role in secondary classes need to be clearly outlined. At present, in most states, most of these teachers have not been deployed in the schools but rather at the block headquarters with no defined role and responsibility.

PAB advised that States should ensure that all these special education teachers (for whom the financial support is being made from IEDSS) should be deployed in the school(s), and if they are serving more than one school in the vicinity then there formal deployment should be with the school having larger number of CWSN children.

PAB also requested NCERT to guide the States by detailing the role of special education teachers at the secondary level and if need be modify the curriculum to meet the needs of CWSN children. Even though the IEDSS scheme has been subsumed under the RMSA, the planning and implementation of this component is still being carried out in an isolated manner, with some of the States/ UTs still implementing the interventions under this component totally through NGOs which is adverse to the overall objectives of scheme which envisages State as the prime implementing agency and NGOs role being limited in aiding and supporting the State.

The PAB stressed that Secondary Schools need to be made more inclusive for CWSN, with adaptations to infrastructure to be planned under the RMSA non-recurring / civil works component, while the teacher training for improving inclusive practices (targeted at CWSN) of Subject teachers should be within the RMSA teacher training package.

- (iii) **UDISE:** The issue with regard to **UDISE data** of the state was also raised. In the current year, MHRD/ TSG has used UDISE data to verify the distance from the UPS to the proposed secondary school and on the basis of distance shown in the UDISE data, the current year proposal for establishing new school has been appraised. However, the state claims some technical problem in that column no 19B of the UDISE DCF which results in inconsistency where the distance from UPS to Secondary Schools is shown as zero in many cases even if the actual distance is 6 or 15 Kms and due to this discrepancy in the data, proposals for new school could not be found eligible for upgradation.

NUEPA was requested to look into this and the State may pursue the matter of correcting the UDISE data with NUEPA.

Though the timeline for sending the UDISE data (elementary and Secondary) to NUEPA is in December every year, it is seen that that States have not been able to send their UDISE data to NUEPA on time, which in turn affects and causes delay in the appraisal of RMSA plans, since they are based on the UDISE data. There are discrepancies in the UDISE data , which are reflected in the mismatch between this years' data (2013-14) and last year's data (2012-13).

The coding /categorization (lowest class/ highest class) is being followed differently in different states, resulting in various interpretations of the number of schools, for a same set of schools. Thus, while in Kerala, a school is given a single UDISE code for the Primary, Upper Primary, Secondary and Higher Secondary, in Andhra Pradesh, Madhya Pradesh, Chhattisgarh, Rajasthan and Odisha, etc, the UDISE code for Primary School is different from the code of the Secondary, from that of the Higher Secondary, etc, resulting in these States showing a higher number of government schools.

Reference was made to the 3rd RMSA JRM aide memoire which suggested tracking of children who have passed out of Class VIII to ensure that they get enrolled in Class IX, using simple techniques of identifying clusters/feeder schools to a Secondary school

PAB requested NUEPA to clarify this and this is especially critical since the UDISE will be the official data from this year onwards.

- (iv) In view of the limited availability of funds under the programme and also the fact that States have been unable to act on previous approvals relating to recruitment and appointment of staff , PAB indicated that approvals regarding Lab Attendants, Librarians and Multi task Support Staff previously committed but not yet acted upon be revoked with immediate effect. Approval/Commitment for salary was for that particular year and if not acted upon and not revalidated specifically, later on stands withdrawn. Commitment of financial support towards this category of support personnel, which is generally sourced on a contractual basis, will also be reviewed as part of the Annual Plan and is subject to availability of funds after provisioning for core set of commitments including teacher's salary.
- (v) PAB also took note of huge backlog in recruitment and appointment of approved teachers. In view of the limited fund availability under the scheme, it was noted that provision of salary under the annual recurring grant shall be earmarked and committed only for personnel formally in place. Any subsequent appointment commitment of RMSA funds will be subject to availability of funds in the current year.

8. Ms. Caralyn K. Deshmukh, Director (RMSA -1) gave a detailed overview of the status of implementation, planning and monitoring of RMSA in Punjab. In the presentation, various aspects of implementation of RMSA scheme in the State including area of concern, major issues, decreasing Education Indicators (GER), progress of recurring and non-recurring approved to the State under the RMSA were highlighted.

9. Areas of concern:

Financial management is a weak area in the State and needs to be strengthened. More attention need to be given to the accuracy of Utilization Certificates, Audit Reports – which need

to be more detailed and reflect the expenditure at all the levels of implementation- State, District, Schools and other agencies handling other activities of RMSA. It has also been seen that recurring activities ,the approvals for which, lapse on the 31st of March, gets implemented or continued even to the next financial year, without the Competent Authority approval, which is , not in accordance with financial procedures and principles.

10. Cancellation of previous approvals- PAB cancelled following previously approved works under strengthening of existing schools and new schools

- 8 schools where location has been changed by state
- 2 schools (2013-14) where no components were approved under strengthening .
- 13 schools(2011-12) approved in 2009-10 with the components-23 Science Lab: 3 Computer Room, : 3 Art Culture Rooms, 17 Library, 7 Additional Classrooms 6 Drinking Water and 9 Toilets:

11. Decreasing trends in educational indicators: Low GER, NER and high dropout rate was observed as compared to last years' indicators.

12. Areas of Strength:

- The State's GER at Secondary level is 77.40%.
- State government has taken initiative to set up **126 Adarsh Schools** with at least one school in each constituency in the PPP mode, 26 of which are already functional. For the improvement of secondary schools in Punjab NABARD has extended special assistance under the project "Special Assistance to Secondary School", As many as 351 high and secondary schools in the state have got a assistance from NABARD for the infrastructure

- During the year 2012-13, according to the States' report, a total Rs. 3.68 crore has been donated by the Community (through SMDCs in Government Schools for the Welfare of Schools) till the month of April. Many schools have been built with the help of the community, with the community raising extra funds.

13. Convergence of Schemes:

With regard to the convergence of Centrally Sponsored Schemes in Government schools, 3770 schools are covered under RMSA, 3696 schools under ICT @ schools, 1795 under IEDSS schools and no school under Vocational Education.

14. Special Focus Districts (SFDs)

Punjab has 12 Special focus Districts (SFDs) and there are 21 Educationally Backward Blocks (EBBs). As far as coverage of SFDs is concerned, out of the approved 222 schools, 116 schools (52.25%), are in SFDs. Out of 4208 schools strengthened under RMSA , 1507 (35.81%), are in the SFDs. Out of 3697 schools supported under ICT@ schools , 2080 (56.26 %) are in SFDs.

15. Progress under RMSA:

14.1 Out of total approved of Non-recurring outlay of Rs 727.42 cr and expenditure of Rs 602.78 cr has been incurred in 2013-14. The State has given the assurance to complete all civil works in the current financial year.

(i) Recurring Interventions:

Out of 222 Headmaster approved, all posts are vacant. Out of 1408 teachers approved, 856 teachers are in position, Out of 222 lab attendant approved, 104 lab attendants are in position and out of 222 Multi Support Staff approved, state has not been able to fill in these posts.

Annual Work Plan and Budget for 2014-15:

16. Thereafter, the intervention-wise discussion was held and the following decisions were taken:

ICT @ School Scheme

17. PAB was informed that so far 3697 schools were covered under ICT @ School Scheme. A total outlay of Rs 24675.20 lakh had been approved to Punjab, the Central Share of which is Rs 18434.65 lakh and the State share being Rs 6243.75 lakh. Out of this, a total of Rs 15488.00 lakh has been released to Punjab. However, under UDISE code discrepancy/ difference in respect of 1 school exist. The proposal of State Govt. to cover the 70 new schools under the Scheme and the proposal for renewal of hardware in 2199 schools (199 schools approved in

2005-06 + 2000 school approved in 2008-09) was not agreed by the PAB due to the huge committed liability already available under the Scheme.

18. It was decided that further release of funds for the committed liability/ expenditure in respect of schools already approved to be covered will be subject to State Govt. utilizing the unspent balance lying with them and providing the UC/Progress Report indicating the Status of implementation of ICT Scheme in the State.

Vocational Education

19. Under the Scheme of Vocationalisation of Higher Secondary Education the proposal of the State of Punjab for introduction of vocational education in 100 schools in both Class 9th and 11th in six trades – Automobile, Retail, Healthcare and Beauty & Wellness, Security and IT&ITeS and strengthening of 129 existing vocational schools was considered by the PAB .

20. Strengthening of vocational education in 129 schools could not be approved by the PAB since in these schools vocational education is offered as a ‘separate stream’ and not integrated with general education. PAB advised the State to revisit the above in consultation with the State Board of Education.

21. In light of the learning’s from the Haryana pilot and the fact that the State was implementing the scheme for the first, PAB advised that the State should introduce vocational education in class 9th and not simultaneously in Class 9th and 11th, as students find it difficult to cope with extra learning of level 1 and 2 which feed into level 3.

22. After detailed discussions, PAB approved the proposal for introduction of vocational education in 100 schools across 22 Districts of the State from Class 9th Class onwards from the academic session (2014-15) in NOS aligned job roles in six trades as listed above, in accordance with the Revised Scheme of Vocationalisation of Secondary and Higher Secondary Education.

23. List of schools along with UDISE code and trade mapping is placed as **Annexure IV**.

24. While approving the proposal PAB clarified that under the Scheme vocational education should be taught as an additional subject (6th Subject) at the secondary level and cannot be taught as a 7th subject .At the higher secondary level, vocational education is to be taught as a compulsory elective. The State was requested to take up the matter with the State Board of

Education and firm up the scheme of subjects on the above lines under intimation to the Ministry before the start of the next academic session.

25. PAB explained at length the importance of assigning sufficient teaching and learning hours to the subject, raising the stature of vocational education at par with other subjects while creating clear pathways for developing skill proficiency within the education system.

26. Since the revisions in the Scheme were approved by the Cabinet on 12th Feb 2013, PAB agreed to the request of the State to provision for funds under as per the revised norms .

27. Accordingly, introduction of vocational education in 100 schools in Punjab was approved by PAB for **Rs. 1766.50 lakh** excluding civil works, with a central share of **Rs. 1324.87 lakh** as per the financial estimates drawn in accordance with the revised scheme of Vocationalisation of secondary and higher secondary education .

28. PAB agreed to release the first installment of 50 % of the total Central Share of **Rs. 662.43 lakhs** after deducting an amount of Rs. 146.18 lakhs lying unspent with the Government of Punjab under the pre revised scheme.

Girls Hostel Scheme

Non-recurring grant

29. Since the provision of boundary wall for 9 girls hostel was already included in the central share already released to the States to all the 21 hostels and the PAB meeting held in 2013-14 had already taken note of this fact and expressed its inability to consider for approval ,the same was reiterated.

Recurring grant

30. The State Govt. has proposed the recurring grant for 21 hostels in respect of 1050 wards staying in the hostel with a total outlay of Rs.174.72 lakh. Since the proposal is in order as per the norms of the scheme, accordingly the PAB concurred in the proposal of State Govt. of Punjab with a cost of Rs.174.72 lakh as recurring grant.

IEDSS

32. It was observed by the PAB, that States have not been able to give detailed proposals under IEDSS and in most cases it has been totally left to the NGOs to formulate and implement

the proposals. States have completely disengaged themselves of their role and responsibility as the main implementation agency. States are, in many cases forwarding proposals of the NGOs without any diligence at their level which is contrary to the spirit of the Scheme.

33. PAB also noted that since a major financial recurring component of the scheme is of salary for special teachers, the States have to ensure that their annual proposal incorporates and substantiates in detail State's commitments. The commitment of GoI will be subject to it being approved as part of the AWP& B and will be limited to the year in which it is approved.

34. In light of limited availability of funds and the fact that recurring grants lapse at the end of FY, reimbursements will not be entertained beyond the FY unless and until it is specifically sought and more importantly approved and re-validated by the PAB. However, in no case, shall proposals not approved in previous years including teachers salary will be considered for reimbursement.

Non-recurring

35. PAB was also informed that as against the approved amount Rs.2952.20 lakh, in the year 2010 and 2011-12, the Govt. of India has released Rs. 1709.78 lakh for construction of resource rooms and equipment's for resource room. So far the State Govt. has indicated the expenditure of Rs. 1662.99 lakhs details of which needs to be submitted. The State was unable to put forth its action plan as regards the approved works or explain the delay in implementation. In light of this status ,PAB advised the state to review its current implementation status and design a more realistic proposal for fresh consideration. As regards committed but unreleased amount of Rs.1289.21 Lakhs approved for the works not yet implemented, the same shall stand revoked.

Recurring

36. The State Govt. has proposed recurring grant for salary of special education teacher for 249 teachers and student oriented component for 10125 CWSN based on UDISE data. In the meeting it has been informed to PAB that out of 239 teachers proposed only 22 special education teachers are in position and remaining 217 special teachers are yet to be appointed. Therefore, the eligibility for the salary is recommended only for the 22 teachers in position @ Rs. 30500 per month for 10 months also with a special pay of Rs.400 per month. The PAB approved the same. The total outlay comes to Rs. 67.10 lakhs.

37. As regard to student oriented component the State Govt. has submitted the component wise details of 10,125 CWSN. Therefore, as per the recommendation of appraisal, the PAB approved the **outlay of Rs. 303.75 lakhs** for this component.

38. PAB also recommended the environment building programme for 217 blocks @ Rs.10000 per block subject to receipt of blockwise details. Schedule of programme and activities to be taken with a total outlay of **Rs.21.70 lakhs**.

The total outlay thus approved by PAB of **Rs. 392.55 lakhs**.

Approval for 14-15

39. Based on above approvals accorded for various interventions in respect of all five Schemes, the total interventions amounting to **Rs. 14825.49 lakh** including the non-recurring interventions amounting to **Rs. 6576.44 lakh** and recurring interventions amounting to **7817.24 lakh** with the central share of **Rs. 11243.44 lakh** and state share of **Rs. 3582.01 lakh**. The MMER in respect of all these Schemes for the approved interventions will come to **Rs. 431.81 lakh**. The Scheme-wise depiction of the proposals of the State and approvals accorded by PAB in financial term is capitulated in the following table:

40. The release of funds to the RMSA components including funds against previous approval will be further guided by the following conditions:

- (i) The State Administration shall give a written commitment for meeting its share of the RMSA, ICT@ School, IEDSS, Girls Hostel & Vocational Education of the budget approved according to prescribed sharing pattern of the components.
- (ii) SMDCs or equivalent bodies should be constituted and accounts opened to incur expenditure under school grant, minor repair, civil works, and other such expenditures, which have to be incurred only through these bodies as per RMSA norms.
- (iii) The State Government will maintain their level of investment in Secondary education as in 2009-2010 and give the details of this to GOI before the release of second installment.
- (iv) The second installment would only be released after (a) the proportionate installment of State share has been transferred to the State Implementation Society, (b) at least 50% expenditure against available funds has been incurred, (c) utilization certificate has been submitted for funds released in the year 2013-14 and (d) Audit Reports have been submitted for the year 2012-13.

41. The meeting ended with a vote of thanks to the Chair.

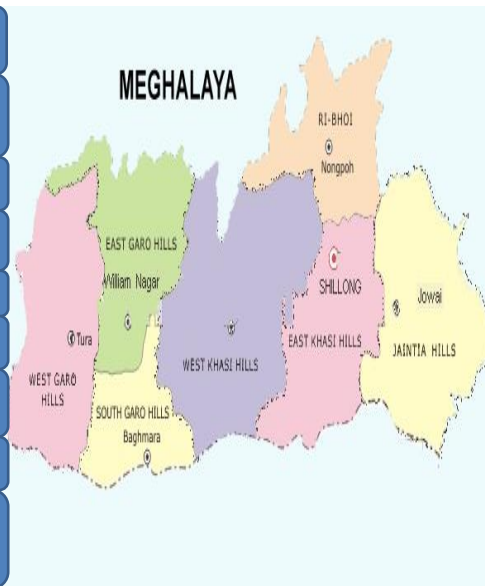

- The State GER for 2013-14 is 61.59%. There is 9% increase in GER when it is compare with last year GER i.e.52.45%.
- Though there is increase in the GER, but the State NER has decreased from 42.01% of last year to 32.73% in the year 2013-14.
- The State is having High dropout rate i.e. 25.93% & 1 district (South Garo Hills) has lowest transition rate (65.11%) & retention rate (59.45%).

Comments:-State need to give convincing clarification for having disturbing indicators. Further, need to take corrective measures and plan accordingly to ensure healthy Education Indicators.

ACCESS

- **Poor GAR (49.91%) at the State level in the area of concern.**
- The State official need to supply the **Govt. notification of opening on New School** as per UDISE & State Report 15 out of 25 schools approved in 2010-11 is functional. 10 schools are yet to be made functional.
- The school which is approved under Sarva Shiksha Abhiyaan (SSA) is not being shown under Govt. Management in UDISE Data which is an area of concern.

Areas of Concern

Civil Work:

Progress Issues:

- No progress has been made in the civil works approved for the year 2010-11, 2013-14
- The State claims that the Unit Cost of Rs. 58.12 lakh is not commensurate with the existing SOR. Therefore, State decided to go for prefabricated structure/classroom for 1 school on pilot basis (approved by EC) against the approval of 25 schools in 2010 - 11 (approved by EC). After ascertaining its success in various aspects, they may go for the same classroom for rest of approved school under RMSA. **But prefabricated structure is not viable solution as the longevity of the same is questionable** (does not last long). This matter to be taken up with the PAB.
- PAB approved 180 components in 2009-10 & 2010-11 under civil works components. The State MGCC completed the civil works of 2009-10 with the reduction of size/dimension of the component to avoid overrun of unit cost.

Areas of Concern

Financial Issues

- Action taken report /reply are awaited for observation on Audit Report.
- State has reported expenditure is Rs 39.11 lakh on MMER which is more than the approval i.e. Rs 7.7 lakh. Balance amount is to bear by the State Govt.
- Expenditure of Rs 1.8 lakh reported on Sports equipment which was approved in 2011-12. PAB may revalidate against 2012-13 approval.

Areas of Concern

Quality:-

Progress Issues

- Teacher Recruitment:- Out of 25 headmaster, 125 subject teacher, 25 lab attendant, 25 support staff. The State has able to filled up 14 post of HM, 39 subject teacher, 15 lab attendant & 15 support staff.
- Teacher Training:- Out of 502 approval of In service training of Headmasters & teachers in 2013-14. The State has able to trained just 33 Headmasters/subject teachers.
- The training proposal lacks need assessment, institutional arrangement, expected outcome & training module.
- There is lack of integrated approach in the planning of the training of teachers (RMSA, IEDSS, and ICT)

Areas of Concern

Girls Hostel (Non-functional):-

- Out of 9 Girls Hostel approved (2012-13) in 9 EBB. No progress has been made none of the hostel are functional.

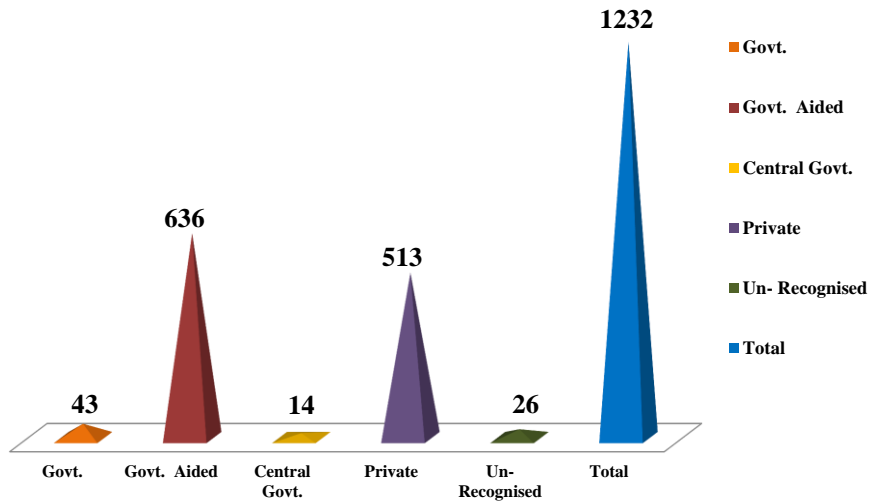

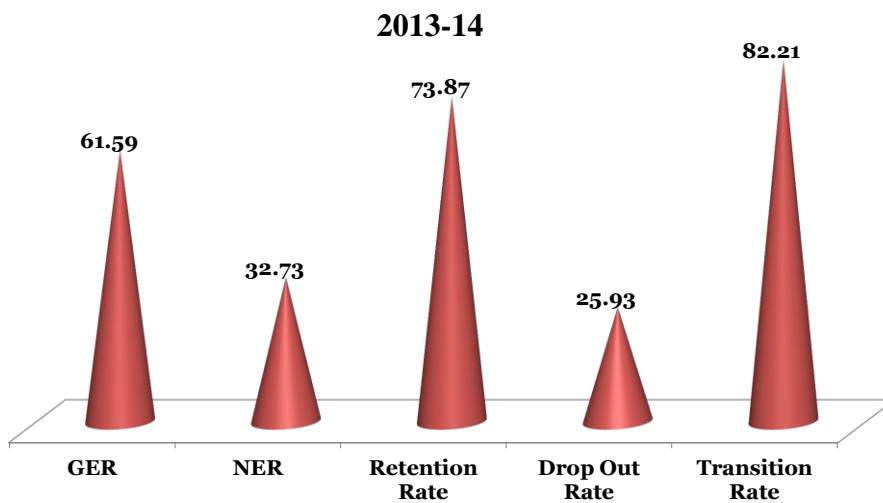

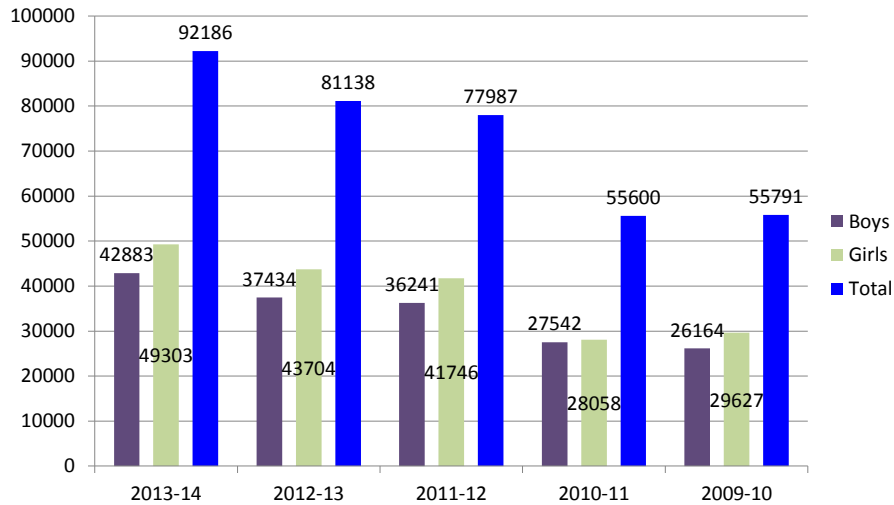

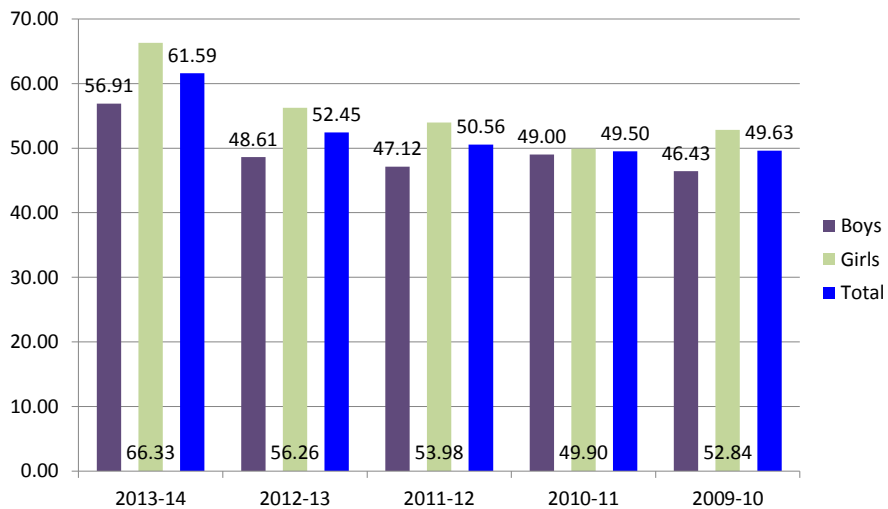

Enrolment (Secondary Level)



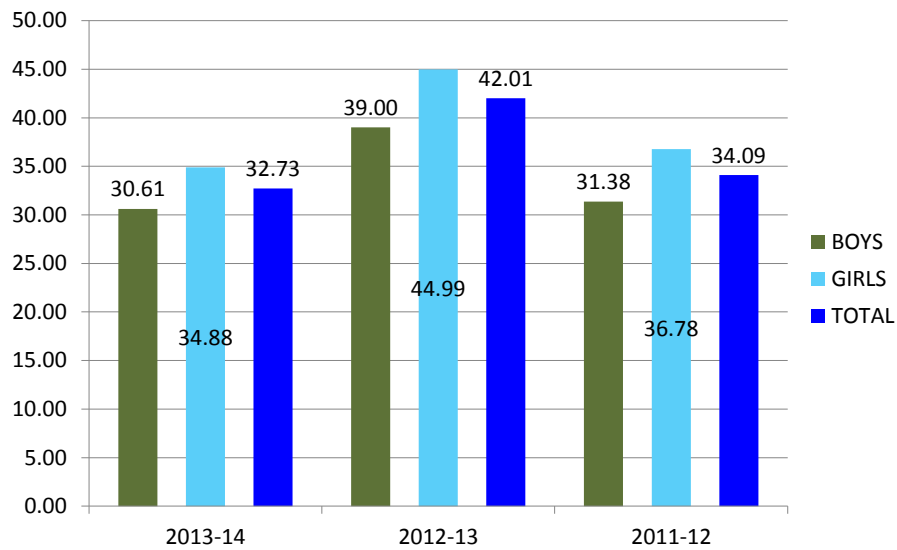

Gross Enrolment Ratio (Secondary Level)



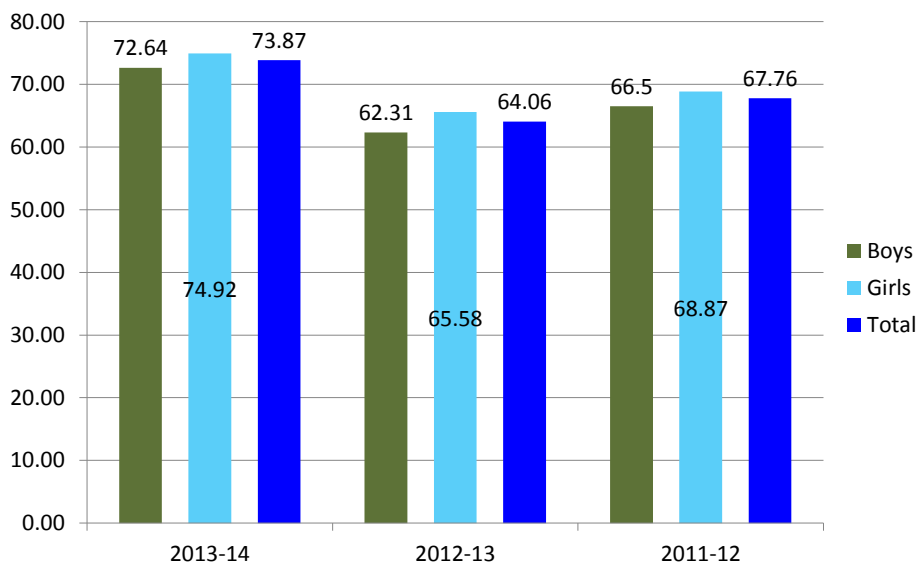

Net Enrolment Ratio (Secondary level)



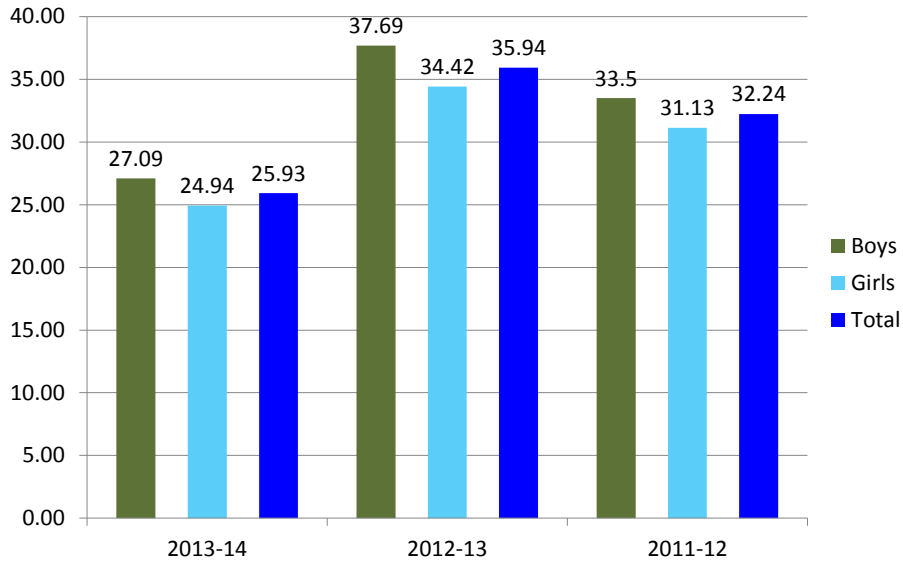

Retention Rate (Secondary level)



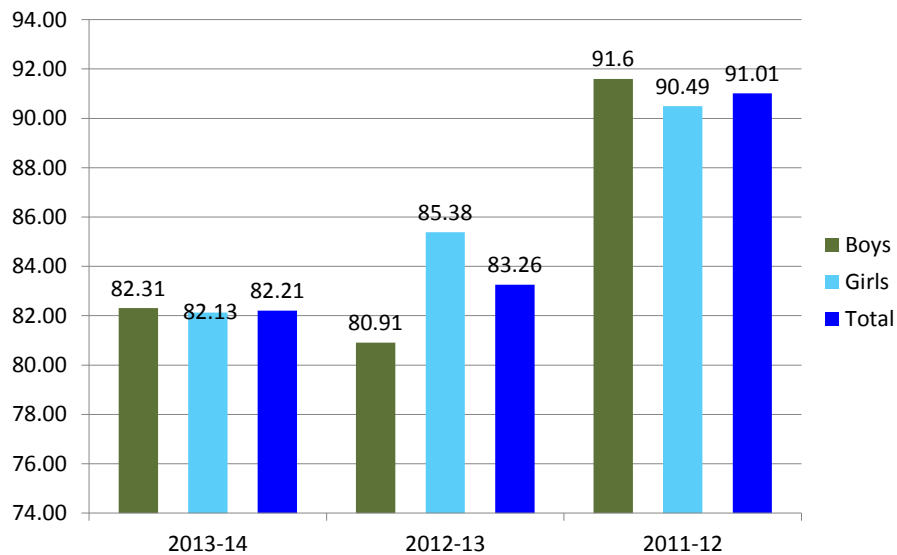

Transition Rate (Class VIII to IX)

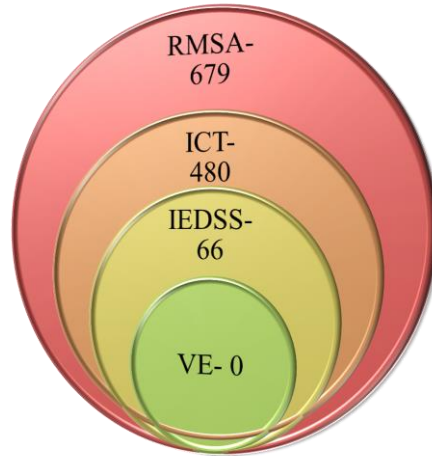

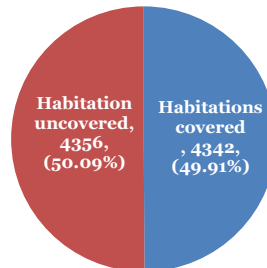

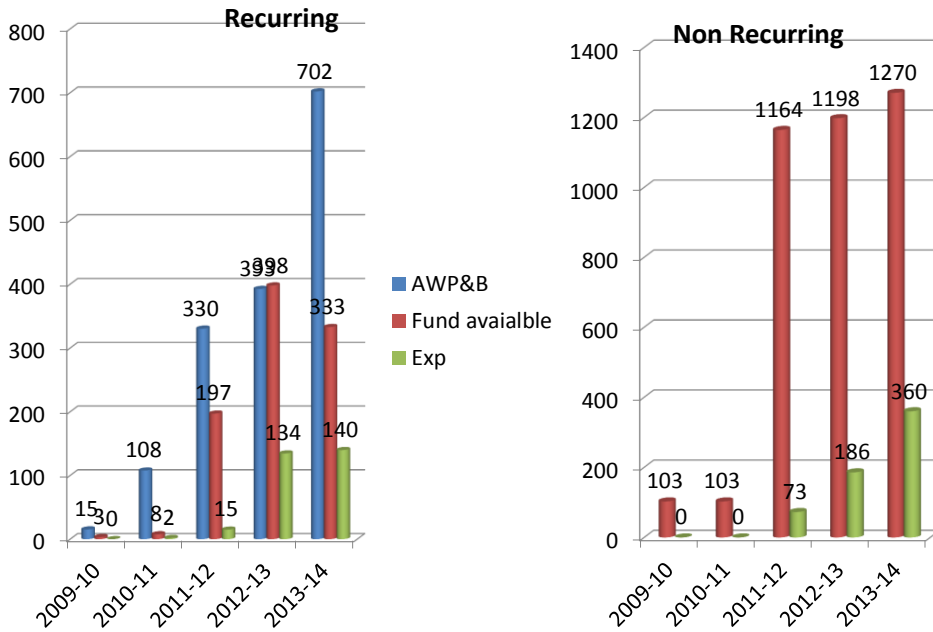

Vacant Teaching Posts Under RMSA

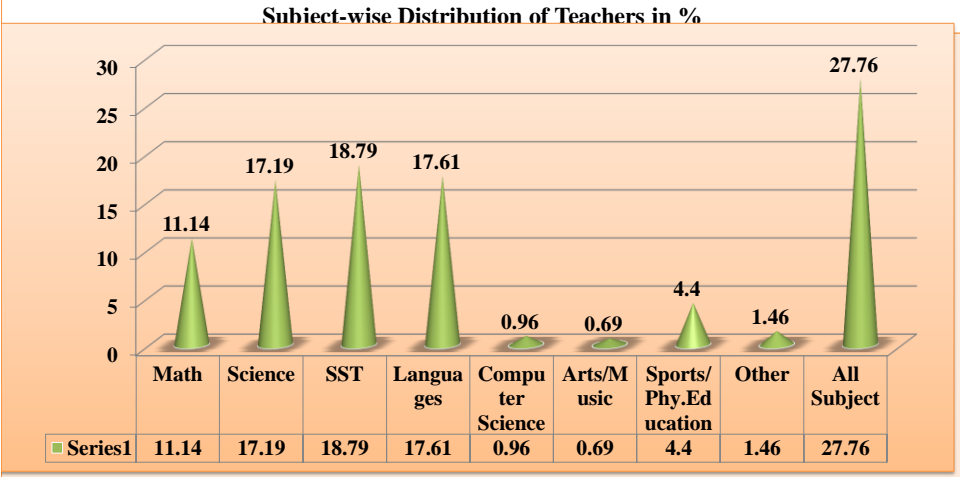

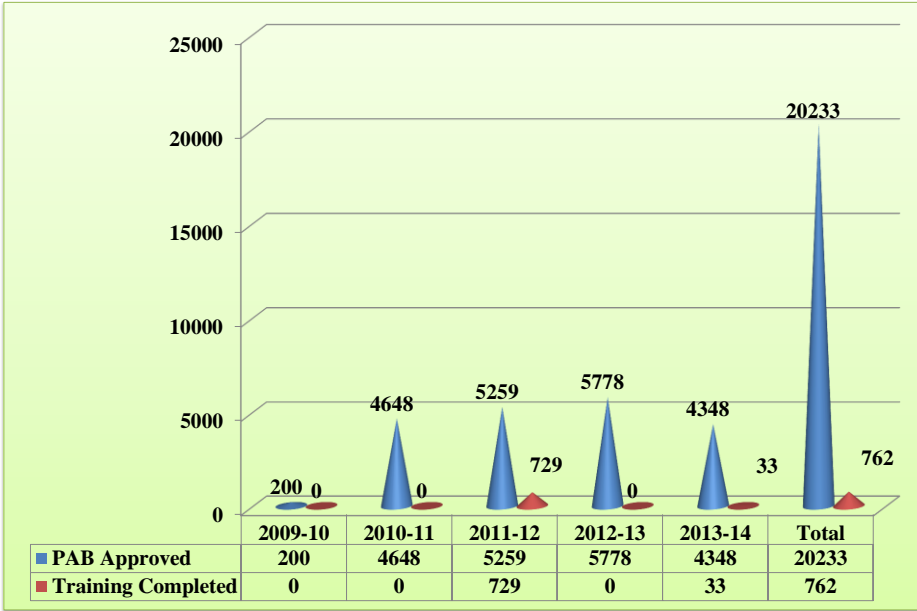

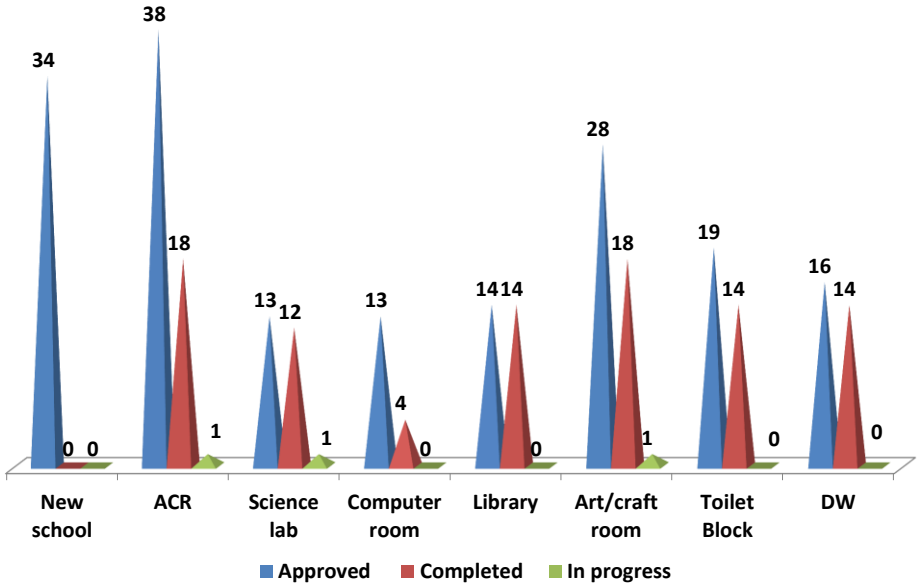
