Corrigendum

In continuation of the Minutes of the RMSA, PAB meeting held on 17.02.2017 for the UT Administration of Andaman & Nicobar Islands issued vide letter No. 6-3/2017-RMSA-II/GH dated 22.03.2017, the following amendments are made: -

(i) On page 5, Para No. 9 under the table "Scheme –wise Approvals : Outlay and spill-over for 2017-18", the amount of non -recurring grant of Rs. 189.676 lakh against ICT component may be read as **Rs. 198.40 lakh.**


