Minutes of the meeting held on the 2nd of February, 2017 for approval of Annual Work Plan and Budget 2017-18 of Tripura under the Centrally Sponsored Scheme of Rashtriya Madhyamik Shiksha Abhiyan (RMSA).


A meeting of the Project Approval Board (PAB) to consider the Annual Work Plan & Budget 2017-18 of the State of Tripura was held on the 2nd of February, 2017 under the Chairmanship of Shri Sanjay Kumar, Joint Secretary, Department of School Education & Literacy.

1. The list of participants who attended the meeting is at **Annexure-I**.
2. Joint Secretary (SE&L) welcomed the participants. Thereafter, a presentation was made by Deputy Secretary, RMSA-IV highlighting the overall status of secondary education in the State, areas of concern and details of the proposal of Annual Work Plan and Budget (AWP&B) for RMSA for 2017-18. A copy of presentation is at **Annexure - II**.
3. **Discussions were held on the areas of concern, point wise as follows:**

3.1.1 Approval of teachers for 2016-17: Out of 580 teachers & Head Masters (HM) which were approved under RMSA scheme, only 353 teachers are in position and all the 116 posts of Headmasters are vacant.

As per NCTE (National Council of Teacher Education), minimum required qualification for secondary school is B. Ed., but as per U-DISE-2016-17, out of 448 teachers under RMSA only 43 (9.6%) teachers have B.Ed qualification. This has been viewed seriously. The issue relating to professional qualification of teachers was discussed in PAB 2016-17 also and the State was requested to ensure that the teachers acquire B.Ed degree. However, situation has neither improved nor the State has indicated any action plan in this regard. The State was asked to submit a detailed action plan to ensure that all the recruited teachers complete B.Ed. qualifications within 2 years. Release of teachers' salary would be considered only after the State submits the action plan along with the number of teachers enrolled for B.Ed course.

Civil works: Non-completion of the interventions in the schools approved under strengthening during the years 2009-10, 2010-11 & 2011-12 has been viewed seriously and the State was asked to complete all the pending interventions with its own resources. The State has agreed to complete these pending civil works from its own resources.

Vocational Education: The State has not implemented vocational education in schools so far. The State was advised to prepare a roadmap in this regard.

Girls Hostel: The State was asked to expedite the construction of Girls Hostels.

3.1.2 Joint Secretary, MHRD observed that State should ensure timely submission of audit reports and utilization certificates so that the central funds could be released and the implementation of Scheme may not be hampered. He also asked the State to ensure adhaar linking of students enrolled in Government and Government aided schools before 31st March, 2017.

3.1.3 The State was asked to complete the child wise data alongwith Aadhar number/unique ID for all students by 31st March, 2017, as releases under fresh non-recurring outlay will be subject to the child wise enrolment data uploaded on UDISE platform

3.2 Education Indicators:-

- Gross Access ratio of the State is 61.2.
- The overall enrollment has decreased from 141181 in 2015-16 to 134226 in 2016-17.
- GER has decreased from 118.49% in 2015-16 to 94.62% in 2016-17.
- NER has decreased from 89.82% in 2015-16 to 74.97% in 2016-17.
- The dropout rate has increased from **24.36% in 2015-16 to 24.73% in 2016-17.**
- The Transition rate has decreased from 97.99% in 2015-16 to 94.65% in the year 2016-17.
- The Retention rate has decreased from 75.64% in 2015-16 to 75.27% in 2016-17.

The Additional Secretary (Tripura) stated that the decrease in enrolment was mainly due to movement of students due to migration to other states and also overall decrease in population.

7. The release of funds to different schemes will be further guided by the following conditions:

- (i) The state administration will give a written commitment for meeting its share of the budget approved under converged RMSA Scheme according to the prescribed sharing pattern. The provision made in the State budget may also be communicated to the Ministry invariably after presentation of the State budget.
- (ii) SMDCs should be constituted in all schools and bank accounts may be opened by them to take care of school grant, civil works, and other such expenditures.
- (iii) The first installment would be released based on provisional Utilization Certificate for 2016-17 and subject to full release of proportionate State share corresponding to GOI share released during the previous financial year.
- (iv) The second installment would be released only after (a) the proportionate installment of State/UT share has been released, (b) at least 50% expenditure

against available funds has been incurred, (c) utilization certificate has been submitted for funds released in the year 2017-18 and (d) Audit Reports have been submitted for the year 2016-17.

8. The meeting ended with a vote of thanks to the Chair.



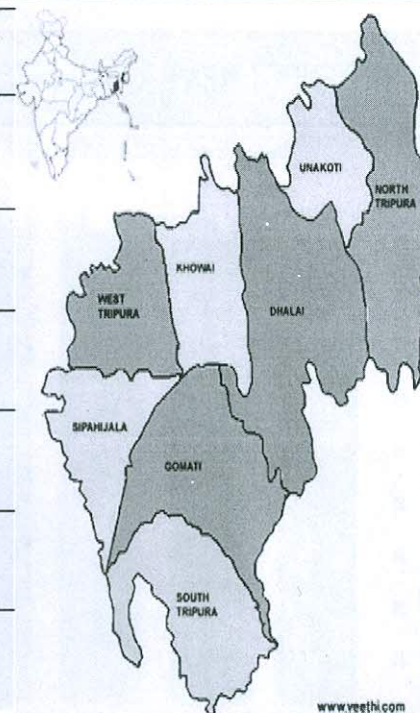

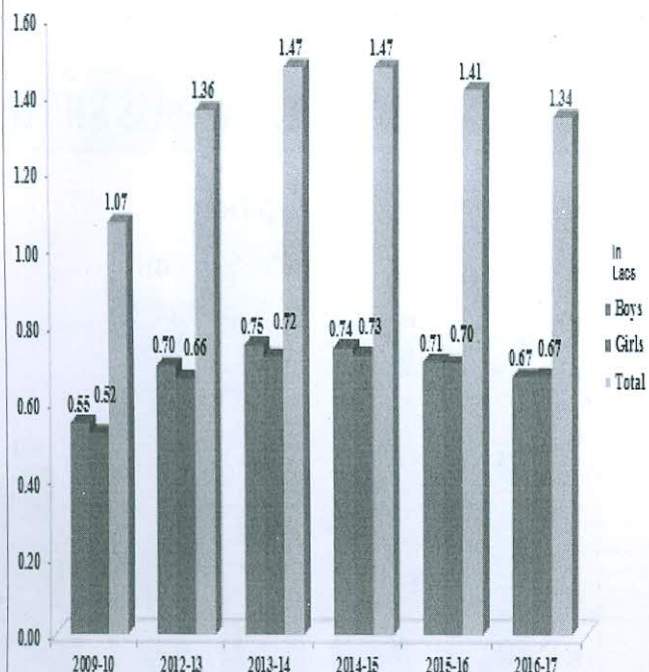

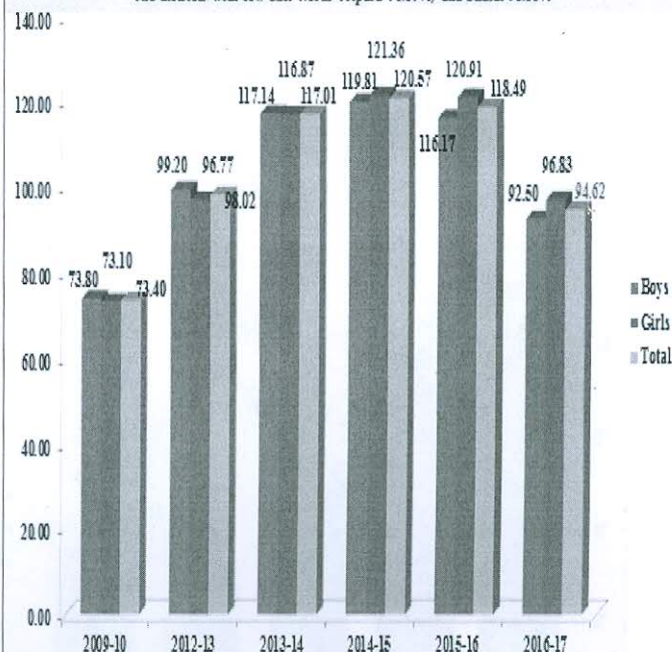
ENROLMENT (SECONDARY LEVEL)

The districts with low GER North Tripura 76.89%, and Dhalai 78.88%



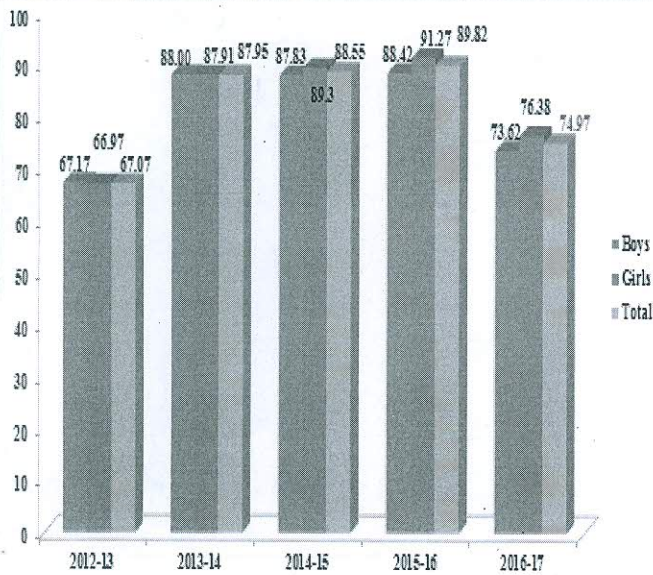

NET ENROLMENT RATIO (SECONDARY LEVEL)

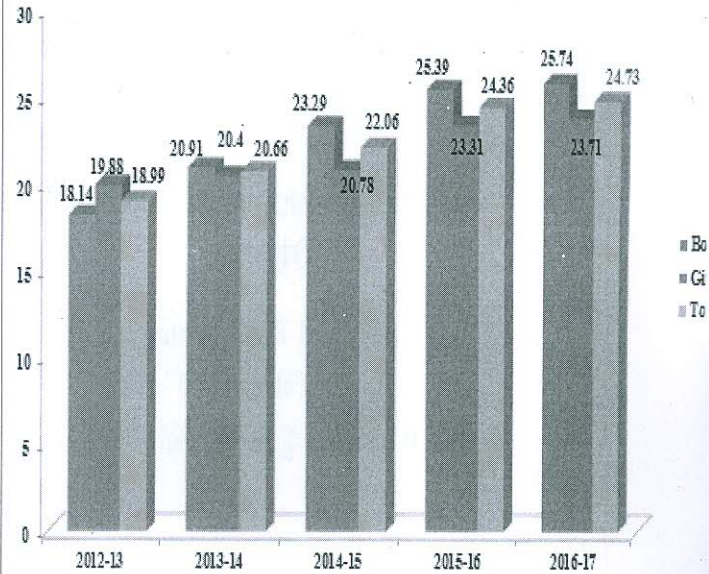

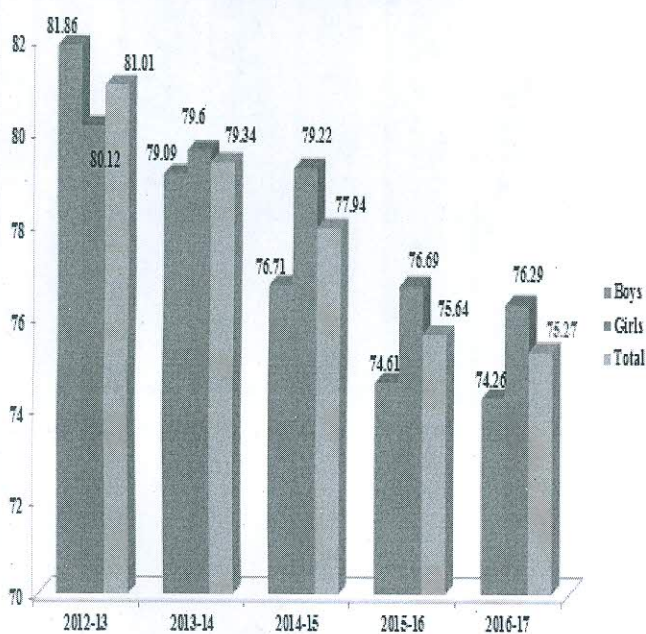
DROPOUT RATE (SECONDARY LEVEL)

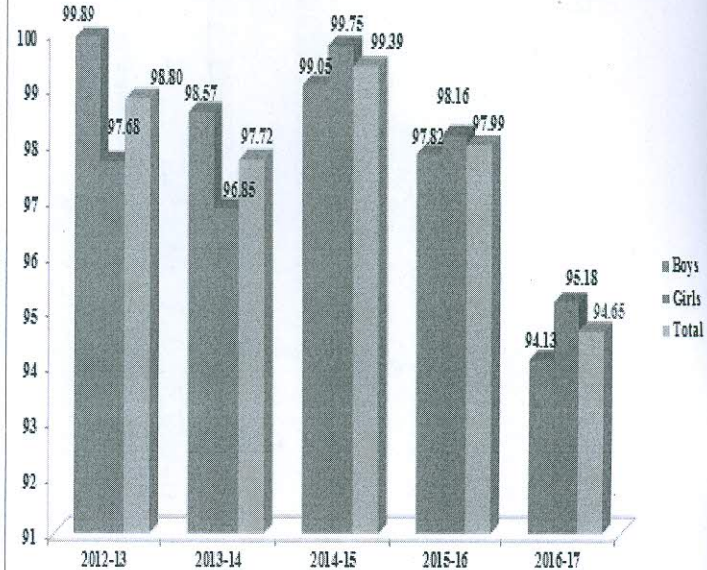

TRANSITION RATE: (CLASS VIII TO IX)

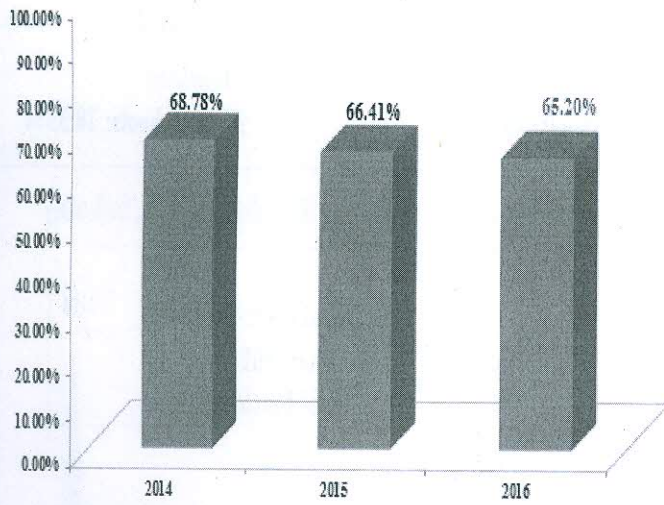

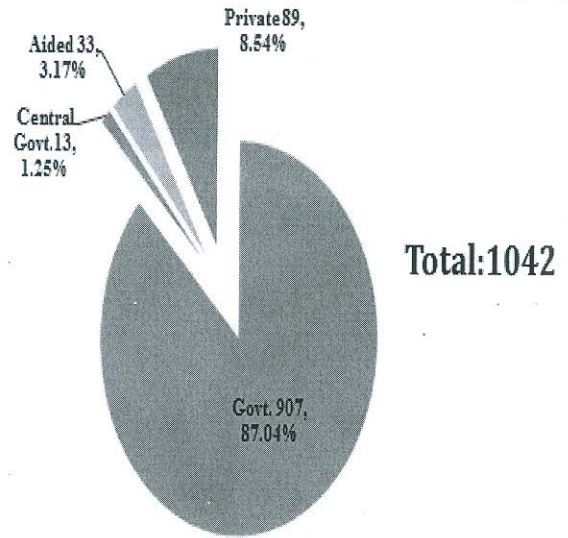
PASS PERCENTAGE (CLASS X)

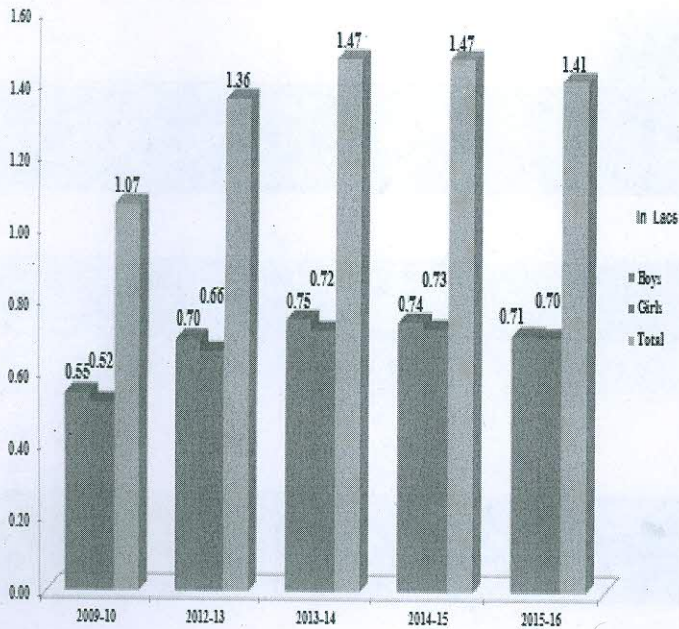

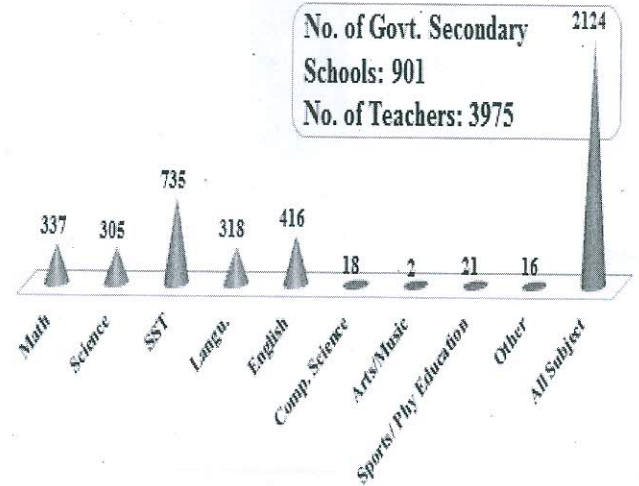

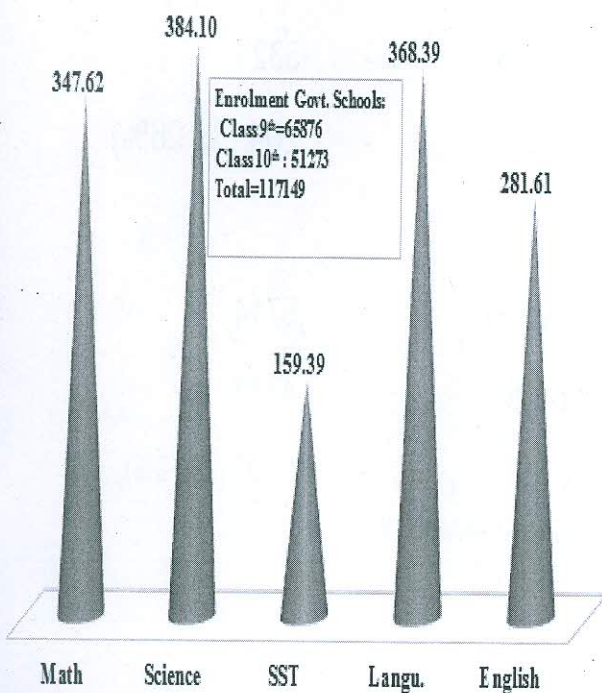
