**Sub: Minutes of the 9<sup>th</sup> meeting of the Project Approval Board (PAB) held on 25<sup>th</sup> May, 2011 to consider RMSA annual plan proposals for 2011-12 for the State of Himachal Pradesh, Manipur, Mizoram, Punjab and Tripura.**

The 9<sup>th</sup> meeting of the Project Approval Board (PAB) for Rashtriya Madhyamik Shiksha Abhiyan (RMSA) to consider Annual Plan proposals of Himachal Pradesh, Manipur, Mizoram, Punjab and Tripura was held on 25<sup>th</sup> May, 2011 under the chairpersonship of Smt. Anshu Vaish, Secretary, Department of School Education and Literacy, Government of India.

2. A list of participants of the meeting is at the **Appendix**.

3. **Himachal Pradesh**

3.1 State Project Director, RMSA, Himachal Pradesh was invited to make a presentation. State Project Director, RMSA, Govt. of Himachal Pradesh shared the progress made in filling up of SEMIS data 2010-11 and the PAB was informed that only 12 schools are yet to complete the data uploading process. Further authentication of SEMIS data is being done. He made a presentation highlighting the progress made in implementation of RMSA programme during the last two years. A copy of the presentation is at **Annexure-I**.

3.2. State Project Director, Himachal Pradesh, informed the PAB that SMDCs under RMSA are being strengthened which was appreciated by the PAB. On the matter of retirement of teachers, a policy decision has been taken to make an offer teachers who are due to retire to continue their service till the end of the academic year. This has been done with a view to avoid disruption in teaching learning process as well as to avoid teacher vacancies in the middle of the session.

3.3. Dr. Jena, Chairman NIOS, suggested that States should be supported through RMSA in the open schooling system. It was suggested by Secretary (SE&L) that NIOS should develop a strategy in this regard. Chairman, NIOS said that he would need to have a dialogue with the States / UTs after which NIOS would formulate a proposal for support to open schooling under RMSA.

3.4 Secretary (SE&L) expressed concern about the delay in fund release to the States as well as the problem of reimbursement of funds to the States. She said that these procedures need to be smooth out. She directed the section, TSG and the IFD officials to work out a procedure which will minimize the time lag between approval and fund release.

3.5. Under the Annual Plan 2011-12, State Government proposed to open 26 new secondary schools by way of upgradation of upper primary schools. The appraisal team observed that out of 26 schools, 22 schools are proposed at a distance of either 5 K.M. or more from the nearest secondary school and the potential enrollment in these schools ranges from 16 to 45. PAB decided that access to secondary schooling is a priority, and approved 22 new one section schools in Himachal Pradesh for 2011-12. For the remaining 4 schools, projected enrolment and distance from the nearest secondary school was not given.

3.6. It was pointed out by the appraisal team that out of 45 new schools sanctioned during 2010-11, the State Government has on its own made some changes of schools. The PAB was told that no financial sanction has been issued for these schools. Secretary (SE&L) stated that deviation from PAB approval is not desirable. If changes have to be made, prior approval of PAB must be obtained. She advised the State to submit a detailed proposal with full justification for the changes, which the State agreed to.

3.7. For strengthening of secondary schools, the State Government proposed 320 existing secondary schools. The appraisal team clarified that all these strengthening proposals were examined as per SEMIS data 2009-10 provided by the State Government. Accordingly PAB approved the strengthening or 320 existing secondary schools as per details below:

3.9. The State Government informed that for quality related interventions, they will submit supplementary proposal in due course. The supplementary proposal has been received and it is being appraised separately. The detailed physical and financial outlay approved under annual plan 2011-12 is given at **Attachment-I**.

#### 4. MANIPUR

4.1 Secretary (Education), Government of Manipur made a presentation highlighting the status of Secondary Education in the State, progress made under RMSA during 2009-10 and 2010-11 and the Annual Plan proposal for 2011-12. A copy of presentation is at **Annexure-II**.

4.2 PAB observed that as per SEMIS data 2010-11, percentage of trained teachers in Govt. Secondary Schools is only 24.39% which is a major concern. The State team clarified that Manipur does not have sufficient teachers training colleges. PAB advised the State not to recruit untrained teachers under RMSA. PAB also observed that more than 30% of the 3121 teachers in existing Government secondary schools are part time teachers. However, the part time teachers have been recruited through written test by the Dept. of Education after obtaining Cabinet approval. School Management and Development Committees (SMDCs) have been formed in all Govt. secondary schools including 44 new schools sanctioned in the year 2009-10 and 23 schools of 2010-11.

4.3. It was noted that out of 44 new schools and 23 new schools sanctioned in 2009-10 and 2010-11 respectively. The State has incorporated only 55 approved schools in their notification dated 30.3.2011. Secretary (SE&L) stated that deviation from PAB approval is not desirable. If changes have to be made, prior approval of PAB must be obtained. She advised the State to submit a detailed proposal with full justification for the changes, which the State agreed to.

4.4 The State government proposed to upgrade 91 upper primary schools into secondary schools under the Annual Plan 2011-12. It was stated that school mapping exercise has been done using geospatial applications. The appraisal team found that the potential enrolment in class IX in all 91 proposed schools varied from 10 to 74. Considering the potential enrolment of 25 and 50 (to open new schools with 1 section

and 2 sections respectively) and distance norm of 5 K.M., 45 schools with 1 section and 4 schools with 2 sections were approved by PAB. This decision was taken based on special considerations of rural Manipur being a low density area.

4.5 For strengthening of existing schools, the State Government proposed to fill the gap existing in 224 schools, which were approved in 2009-10. It was pointed out by the appraisal team that in the year 2010-11 gaps in 224 schools had already been addressed. Thus no schools were approved for strengthening in 2011-12.

4.6 The State Govt. had proposed major repair of classrooms in 126 schools. 206 classrooms in 100 schools were approved for major repair at a cost of Rs.188.54 lakh.

4.7 Based on the State Government's proposal for residential quarters, 8 quarters in 2 schools were approved.

4.8 For recurring components, based on State Government proposal, the following interventions were approved by PAB as per details given below:

4.8 The detailed physical and financial outlay approved under annual plan 2011-12 is given at **Attachment-II**.

## 5. MIZORAM

5.1 The State Project Director, Govt. of Mizoram made a detailed presentation of the State Government's proposal. SPD, RMSA, Govt. of Mizoram briefed the PAB about the status of progress made so far under RMSA. The PAB was informed that 23 new schools approved during 2009-10, will be functional within 2 months. Completion of construction of buildings stood at 92%. A copy of the presentation is at **Annexure-III**.

5.2 It was noted that Mizoram has a large number of vacancies of teacher posts, as well as the fact that teacher rationalization policy is yet to be put in place.

5.3 Under the Annual Plan 2011-12, the State Government proposed to open 36 new secondary schools (6 schools with one section and 30 schools with two sections). The appraisal team observed that in these proposed schools, the potential enrolment of class IX students varies from 6 to 141. Considering the demographic scenario of Mizoram (hilly and difficult terrain), potential enrolment of minimum 25 and 50 was taken as the criterion to open new secondary schools with one section and two sections respectively. Accordingly, 22 schools with two sections and 4 schools with one section were approved by PAB.

5.4 For strengthening of existing schools, the State Government proposed to fill the gap existing in 199 schools, which were approved in 2009-10 and 2010-11. It was pointed out by the appraisal team that in the year 2010-11, gaps in 154 schools had already been addressed. Similarly, infrastructure strengthening in 45 schools was sanctioned in 2010-11 as per SEMIS data. Thus no schools were approved for strengthening in 2011-12.

5.5. Major repair of classrooms in 79 schools were proposed by the State Government. Based on appraisal, 15 classrooms in 6 schools were approved by PAB amounting to a total of Rs.14.56 lakh.

5.6 The State Government proposed construction of 19 residential quarters for teachers. While discussing the proposal, Secretary (SE&L) said that the States may need to look at construction of residential quarters in clusters instead of constructions attached to a single school. Construction of 15 residential quarters was approved by the PAB.

5.7 For recurring components, based on State Government proposal, the following interventions were approved by PAB as per details given below:

5.8 For guidance and counseling the State Government did not propose a crucial component i.e. Resource persons, Research Assistant for development work / field work, hence the proposal was not considered.

5.9 The detailed physical and financial outlay approved under the Annual Plan 2011-12 is given at **Attachment-III**.

## 6. Punjab.

6.1 The State Project Director -cum- Special Secretary, Secondary Education, Government of Punjab made a detailed presentation of the State Government's proposal. SPD, RMSA, Govt. of Punjab briefed the PAB about the status of the literacy rate and education at primary, upper primary and secondary levels. Initiatives of the State Government in secondary education such as setting up of Adarsh School in each constituency through PPP mode, free education to all girl students' upto class 12, free uniform to children of backward classes and economically weaker sections, strengthening of 67 high schools from State resources, etc. were included in the presentation. A copy of the presentation is at **Annexure-IV**.

6.2 SPD, RMSA also informed the PAB about the progress made under RMSA. 70 new schools sanctioned during 2009-10 and 79 schools sanctioned during 2010-11 have been functional from 2010-11 and 2011-12 respectively.

6.3 Under Annual Plan 2011-12, the State Government proposed to open 162 new secondary schools by way of upgradation of upper primary schools. The State also pleaded the case for relaxation of norm in certain areas where there are natural barriers including in the district of Firozpur (Bet and Kandi area) as well as in international border areas. The appraisal team observed that out of 162 schools, 53 schools fulfill the criteria of potential enrolment of 70 and distance norm of 5 K.M. Hence these 53 schools were considered for two section schools. For schools in areas with natural barriers, the potential enrolments in these areas were kept at 25 and 50 for opening of new schools with one section and two sections respectively. Accordingly, 7 schools in these natural barrier areas and 9 schools in international border areas were considered with two section schools. Where potential enrolment in these two types of areas were less than 50 and more than 25, opening of 4 schools with one section was approved by PAB. Hence, total 69 schools with two sections and 4 schools with one section were approved.

6.4 For strengthening of existing schools, the State Government proposed to strengthen 1500 existing Government secondary schools. The appraisal team recommended the strengthening of existing 1375 schools, as the information of vacant space for remaining schools was inadequate. The State Government clarified that in 107 schools, where vacant space is not sufficient to create infrastructure under RMSA, vertical expansion of the existing structure will be done only after detailed technical examination of the existing structure. PAB directed the TSG-RMSA to re-examine the proposal in light of the discussion with State Government. The State Government physically inspected 107 schools and found that 68 schools fulfill the aforesaid criteria. Thus a total of 1443 schools (1375 + 68) were approved as per details given below:

6.5 For major repair the State Government had proposed in 305 schools. Based on the evaluation made by the appraisal team, PAB approved major repair of 189 classrooms in 72 schools amounting to Rs 108.24 lakh.

## **7. Tripura.**

7.1 The Additional State Project Director, Govt. of Tripura made a detailed presentation of the State Government's proposal. He briefed the PAB about the status of progress made so far under RMSA. The PAB was informed that out of 97 new schools approved during 2009-10, infrastructure facilities such as additional class rooms, science laboratory, lab equipment, library rooms, art & craft rooms, computer rooms have been created in 50 schools. Further, 42 new schools sanctioned during 2010-11 have been functional from January, 2011. A copy of the presentation is at **Annexure-V**.

7.2 Under the Annual Plan 2011-12, State Government proposed to open 46 new secondary schools. The appraisal team observed that as per the minimum distance norm of 5 K.M. from the nearest secondary school, 34 schools could be considered for upgradation to secondary schools. The State Govt. requested the PAB to consider applying the norm of 3 K.M. (as per the State's norm) to open new secondary schools in view of the demographic scenario of the State. The PAB felt that the State had a valid case and that norms approved for hill States such as Himachal Pradesh should be applied to Tripura as well. It was also noticed that out of 46 schools, 4 schools were already upgraded in 2010-11. In 1 school, the potential enrolment was 22, which were not agreed to by PAB for upgradation. In the remaining 41 schools, 26 schools and 15 schools with potential enrolment of minimum 25 and 50 were approved with 1 section and 2 sections respectively.

7.3 For strengthening of existing schools, the State Government proposed 76 schools under the Annual Plan 2011-12. The appraisal team stated that out of 76 schools, minimum required land is available in 71 schools, where additional infrastructure could be created. Accordingly, PAB approved the strengthening of 71 existing secondary schools as per details given below:

7.4 The State Government proposed the construction of 30 residential quarters, and PAB observed that the quarters should be set up in cluster mode. Accordingly, 24 quarters in 08 locations for 11 schools were approved by the PAB.

7.6 As regards the proposal for accreditation of 10 schools in Tripura by the Quality Council of India (QCI), it was decided that the Ministry of HRD will take up the matter with QCI for a holistic approach to cover schools in all States/ UTs.

## **8. General Issues**

8.1 During the discussions on the States' RMSA proposals, it was seen that data of most States suffer from discrepancies. This needs to be tackled seriously by the State Governments.

8.2 During discussion the fact of the limit of amount of Rs 4.00 lakh for major repairs for a school was pointed out, Secretary (SE&L) mentioned that some changes need to be made in the cases of extremely dilapidated school building and need for sanctioning new or reconstruction of the building in place of the old dilapidated building. This needs to be taken up for examination and discussion in the scheme for 12<sup>th</sup> Plan.
