RESOLUTION


Whereas the previous Council of the Indian Council of Philosophical Research (ICPR), New Delhi was constituted on the 09th March, 2019 and the term of the Council having expired on 08th March, 2022, the Government of India has resolved to reconstitute the Indian Council of Philosophical Research under Rule 3 of the Memorandum of Association and Rules of Indian Council of Philosophical Research, New Delhi. The tenure of members is for a period for three years from the date of issue of resolution except for the Chairman and the Member Secretary in whose case the tenure is mentioned below. The Council with following members is constituted with immediate effect:

- A. Chairman - Prof. Deepak Kumar Srivastava, Vice Chairman,
UGC - in additional charge as Chairperson, ICPR till
appointment of regular Chairperson or till further
orders, whichever is earlier.
- B. Eight representative of different organizations:
- i. A representative of the University Grants Commission;
 - ii. Two representatives of the Indian Philosophical Congress;
 - iii. A representative of the Indian Council of Social Science Research;
 - iv. A representative of the Indian Council of Historical Research;
 - v. A representative of the National Science Academy;

- vi. Joint Secretary/Additional Secretary of the Concerned Bureau of Ministry of Education;
- vii. Financial Advisor, Deptt. of Higher Education, Ministry of Education.
- C. Members nominated by the Government of India:
- i. Prof. (Retd.) K. Sambathkumar, Department of Philosophy, Pachaiyappa's College, Chennai;
- ii. Dr. Girishkumar T S, Maharaja Sayajirao University of Baroda, Gujarat;
- iii. Dr. Pankaj Kumar, Department of Philosophy, Dr. Shyama Prasad Mukharjee University;
- iv. Prof. L. Bishwanath Sharma, Central University of Manipur;
- v. Dr. Namita Nimbalkar, Department of Philosophy, University of Mumbai;
- vi. Prof. Nirmalya Narayan Chakraborty, Department of Philosophy, Rabindra Bharti University, Kolkata – Former Member Secretary of ICPR, New Delhi;
