**MONTHLY SUMMARY FOR THE CABINET FOR THE MONTH OF AUGUST, 2018:**

**1. Important Policy Decisions Taken and Major Achievements During August, 2018**

**A. Meeting for Social Media Strategy of SWAYAM Courses was held on 02.08.2018**

– Aim of the meeting was to popularize SWAYAM Course by using social media platform.

**B. Meeting of e-Shodh Sindhu (eSS) Review was held on 03.08.2018** –A review meeting held under the chairmanship of Secretary(HE) and the following points were reviewed :

- a. Growth of project.
- b. Fund requirement.
- c. Optimal use of e-resources, possibility of providing the same to research scholars, students and faculty on actual use basis by providing credit points to them may be considered. INDLIBNET was requested to work on this possibility.

**C. Meeting of 3rd NMEICT Phase-II Review was held on 03.08.2018** – Meeting was chaired by Secretary (HE).Review of projects that come under NMEICT was taken. NDL, Virtual Labs, e- Yantra, FOSSEE, BAADAL, UEAF are some of the projects that come under NMEICT.

**D. Meeting of 7th SWAYAM Board was held on 13.08.2018** – meeting held under the chairmanship of Secretary(HE) and the following actions were taken:

- b. Discussion on Action taken and status report

**F. Meeting of National Advisory Committee (NAC) of e-Shodh Sindhu (eSS) was held on 14.08.2018** – meeting held under the chairmanship of Secretary(HE) and the following actions were taken

- a. Confirmation of minutes of 3rd meeting.
- b. Action taken and progress made and new developments since the last meeting of the NAC.
- c. Presentation of New Model and current status of e-SS.
- d. Presentation on the proceeding of the 5th meeting of the National Steering Committee of e-SS.
- e. New Model of e-SS for the years 2019-20.
  - f. Constitution of Negotiation Committee for providing Access to plagiarism detection software to all universities (including CFTIs).
  - g. Request for intervention of MHRD for Exemption of GST for all payments made for e-Resources under e-SS by the INDLIBNET Centre.

**G. Meeting of Operation and Maintenance of BAADAL by NIC was held on 16.08.2018** – meeting held under the chairmanship of Secretary(HE) and it was observed that BAADAL is an education cloud. It was discussed how this cloud is to be maintained by NIC.

**H. Meeting of 4th Workshop of SWAYAM Prabha was held on 29.08.2018 at AICTE HQ, New Delhi** – meeting held under the chairmanship of Secretary(HE) and the following actions were taken:

- a. New content is to be created in all the channels.
- b. Improvement in most of the channels.
- c. Marketing strategy to be followed.
- d. Pedagogy techniques has to undergo change depending nature of the channel.

**I. National Academic Depository(NAD)** – The National Academic Depository (NAD) has been launched by the Hon'ble President of India on 9th July, 2017. This is a digital storehouse of academic degrees and awards of all Higher Education Institution and School Examination Boards like the CBSE. As on 24th August, 2018, around 1.14 crore academic awards including degrees, marksheets, certificates etc. have been lodged by various academic institutions on NAD.

**J. Centrally Sponsored Scheme of Rashtriya Uchchatar Shiksha Abhiyan (RUSA):** An amount of Rs.4298 crore including Rs.643.01 crore during the current financial year has been released to State Governments since its inception.

**K. University Grants Commission (UGC):** University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/ Ph.D Degrees) (1st amendment) Regulations, 2018 was published in Gazette of India on 27.08.2018. The notification of University Grants Commission (Recognition and Monitoring of Assessment and Accreditation Agencies) Regulations – 2018 was published in Gazette of India on 14.08.2018.

L. A meeting between Secretary (HE) and Director, UNESCO New Delhi was held on 28th August, 2018 at Secretary(HE)'s Chamber, Shastri Bhawan, New Delhi. In the meeting the lease agreement (called Host Country Agreement between GOI and UNESCO for leasing UNESCO House to UNESCO for the period of 99 years w.e.f. 3rd December, 2016) was signed between Government of India and UNESCO Regional Office, New Delhi.
