

1. Applications are invited for appointment to the post of Director, Indian Institute of Technology, Guwahati. The Director of an IIT, being the academic as well as administrative head is expected to have proven administrative, teaching and research background (including significant experience in research guidance at the Ph.D. level) with the leadership qualities to head an Institute of National Importance. The candidate/person should be a Ph.D. with first class or equivalent at the preceding degree in the appropriate branch with an outstanding academic record throughout and a minimum of 10 years experience as a Professor in a reputed Educational Institute (relaxable in case of an outstanding candidate). Applicant should preferably be not more than 60 years of age. The post carries fixed pay of Rs. 80,000/- (revised) per month with usual allowances.
2. Indian Institute of Technology, Guwahati is an autonomous institution fully funded by the Ministry of Human Resource Development, Government of India. The Director will be appointed after obtaining the approval of the Competent Authority based on the recommendations made by the Search-cum-Selection Committee. The Search-cum-Selection Committee will consider applications received in response to this advertisement, as well as nominations received from eminent persons. The appointment will be on contractual basis for a period of five years or till the attainment of 70 years, whichever is earlier, as per usual terms and conditions.

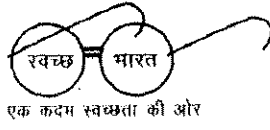


Dear Prof. Chakrabarti,

Please refer to this Ministry's Order F.No. 3-30/2011-TS.1 dated 26th July, 2013 regarding your appointment as Director, IIT Kharagpur for a period of five years with effect from the date of assumption of charge or till the attainment of age of 70 years, whichever is earlier.

2. In this connection, your kind attention is invited to Statutes 7(3) of IIT Kharagpur, which provides that the Contract of Service between the Institute and the Director shall be in writing as set out in Schedule 'A' to the Statutes. Clause 2 of the said 'Contract of Service' provides that the appointee shall be on service under the agreement for a period of five years with effect from the date of joining. Provided that if the appointee on conclusion of the period of service mentioned above is below 70 years of age, his service shall continue till the 30th June of the academic year in which he concludes the said period of service or till he attains the age of 70, whichever is earlier.

3. Keeping in view the above provisions of Statutes, unless you choose to leave, your services as Director, IIT Kharagpur shall continue till 30th June of the academic year.
