Subject: "Provision of reservations in admission for Economically Weaker Section (EWS) students in Central Educational Institutions".

Sir,

I am directed to refer to this Ministry's letter of even number dated 21-1-2019 on the above mentioned subject and to convey allocation of additional funds amounting to Rs.1000.97 cr. to IITs for creation of 6708 additional seats during 2019-20 and 2020-21 for implementation of reservation for the EWS students.

The Institute-wise break-up of additional seats and additional funds allocated is as per Annexure enclosed herewith. The following are broad guidelines for implementation of the scheme:

i. The process of execution of the scheme may start immediately.

ii. The Institute shall send quarterly updates to this Ministry regarding implementation of the scheme including creation and filling of seats, creation/ recruitment of faculty position, etc.

iii. The creation of post/ recruitment of faculty and other staff may be done as

per extant guidelines.

iv. After 2020-21, the additional funds for salary, scholarships, maintenance, etc. would be factored in the regular budget estimates.

- v. The cost of infrastructure projects under OH-35 will be met through HEFA loan for which funds (principal + interest) will be provided by MHRD under OH-31
- vi. The DPRs for infrastructure projects shall not exceed the amount indicated in the Annexure, and shall be submitted by the institution before 1st July 2019 for appraisal/approval as per extant guidelines. After appraisal/approval, the institution shall file application before HEFA for sanction of loan.

vii. No works which are in the negative list as per letter dated 16th July 2018 (copy enclosed) shall be proposed.

viii. No allocations under OH-35 are being made for the IITs which are still under project mode and running below their approved capacity.

ix. Wherever construction of campuses is underway, necessary modification in the design may be attempted in order to optimize the costs.

Subject: Broad guidelines for appraisal of infrastructure projects in CFIsregarding.

Sir,

I am directed to state that the following would be the broad guidelines for appraisal of infrastructure projects for CFIs. These guidelines would be used for appraisal of all new projects which would be posed to the Ministry for appraisal.

**i**) Only the works in the priority list (Annexure-I) would be funded. In case any additional area is to be constructed, the same has to be

adequately justified.

iil The works in the negative list (Annexure-II) would not be funded. If any work under these categories are already sanctioned/started, no further funding shall be released on these works, except that which is needed to bring the work to safe stage and close. Of course, the institution can mobilise funds from other sources for their completion.

The infrastructure entitlements will be for the student strength as iii)

per the sanctioned project.

- In the new institutions, the land shall be developed in parcels of 50 Acres each, with utilities like roads, sewage, garbage disposal system, water facilities etc. Only after full utilisation of this 50 acres, can another parcel of 50 acres be started for land development. The development shall therefore be confined to that part of the land (only) which is functionally required to serve the student strength for the next 5 years.
- This issues with the approval of Secretary, Department of Higher Education, MHRD.
