
2. The information sought for Para no. 3 & 4 is as follows:-

Reference is made to your RTI application dated 01.05.2018, seeking information under RTI Act, transferred to this Institute by MHRD under section 6(3) of the said Act vide their letter No. F.No. A.33-1/2018-TS-1 (June) dated 01.06.2018, which has been received in the office of the undersigned on 08.06.2018.

In this regard, as per the information received from the concerned department pertaining this Institute, point wise reply to queries is appended below;

1. In this matter a committee comprising of the following was constituted by the Institute;
 - i. Prof. Vinay K. Pathak, Vice Chancellor, AKTU Lucknow – Chairman
 - ii. Dr. D.B. Shakyawar, Principal Scientist, ICAR-CSWRI – Member
 - iii. Prof. Sumit Ganguly, Chairman, IIT Kanpur Ethics Cell – Member

The committee after interaction with concerned persons submitted its report, based on which the Board of Governors of the Institute has decided to initiate disciplinary proceedings against all the person blamed by the Fact Finding Committee. Presently, an inquiry under Rule of CCS

7. In terms of the aforementioned order dated 17.04.2018 passed by the Hon'ble High Court, Allahabad, the respondents are required to file their respective counter affidavits. As the order of Hon'ble High Court, Allahabad is only an interim order, there is no proposal to file any appeal against the order. This Institute has no information whether the President's Secretariat has been updated in this regard or not.

Further to above, please refer your letter dated 19.06.2018 wherein you had asked information about the exact date when this matter was reported to the Ministry. In this regard, it is informed that, the Institute had intimated the entire facts to MHRD on 08.03.2018.
