MOST RESPECTFULLY SHOWETH:

1. That the Decree Holder had filed the present petition before the Hon'ble court.
2. That the said matter was referred to the principal counselor Family Court, Patiala House Court, New Delhi and by the best efforts of the principal counselor the said matter was settled.
3. That as per the settlement deed dated 05.11.2019, it was agreed between the parties, that J.D. will pay Rs.9,38,848/- (Rupees nine lakhs thirty eight thousand eight hundred forty eight only) in three installment.

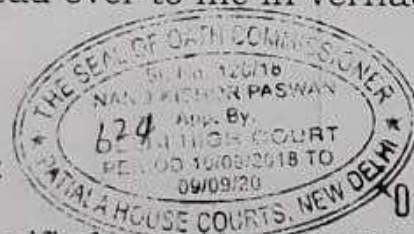
