

A Committee was constituted under the Chairmanship of Dr. K. Kasturirangan which submitted its report to the Ministry on 31.05.2019. Among other various recommendations in the Draft National Education Policy 2019, one of the recommendations is regarding setting up of National Research Foundation (NRF). The process of finalising a National Education Policy is currently ongoing.
A Study in India programme will be launched to encourage foreign students in higher education.
