

INSTRUCTION TO THE CANDIDATE

1. The Candidates are provisionally allowed to appear in the test based on the information submitted by them without verifying their personal details viz. age, qualification, category etc. Before appearing for the CBT, they must ensure that they fulfill the eligibility criteria stipulated by DSE Odisha in all respects. If at any stage of the recruitment/selection process or even after selection, it is found that any candidate is not eligible in terms of the notified eligibility criteria, the candidature/appointment of the candidate will be cancelled without giving any reason / or prior notice.
2. The candidates are required to bring this Admit Card affixed thereon a Photograph, similar to the one uploaded in the application form.
3. The candidates must bring a current & valid photo identity proof in original. Please note that candidate's name as appearing on the Admit Card (provided by them during the process of registration) should match exactly with the name appearing on their photo identity proof. Female candidates who have changed their first / last / middle name after marriage must take special note of this. If there is any mismatch between the names indicated in the Admit Card and Photo Identity Proof, they will not be allowed to appear for the Test. The candidates, who have changed their names will be allowed only if they produce Gazette notification/their marriage certificate /affidavit.
4. The Candidates will have to report in the test centre 60 minutes before the start of the Test. Candidates will neither be allowed to enter the Venue after the Gate Closure Time (10 Minutes before Test starts) nor permitted to leave before completion of the Test.
5. The PWD candidates are required to produce original certificate of disability for verification and submit one photo copy of the same to Invigilator at Test Center before appearing for the examination.
6. PWD candidates who need the facility of scribe must produce permission letter from Director Secondary Education, Odisha. The Voter/ Aadhar ID and certificates of educational qualification of the permitted scribe are also to be submitted at the Test center for verification. A PWD candidate not having such permission shall not be allowed to use scribe.
7. The Test will be conducted through Computer Based Test (CBT) mode. Candidates will have to enter their Application No. as Login ID and Date of Birth as Password to enter the Test module. Before starting the Test, the candidates must ensure that their Names and other details, which appear on their individual screens, are correct.Thanking You
8. In the CBT, there will be 150 questions of one mark each and the duration of exam will be 150 minutes. There will be 0.25 negative mark for wrong answer in the Test.
9. Use of books, notebooks, calculators, watch, pagers, mobile phones, headphones, Bluetooth headphones etc. are not permitted in this test. Candidates are advised not to bring any of the aforementioned banned items to the venue of test as safety arrangement for keeping/deposition of the same cannot be assured.
10. Any candidate found resorting to any unfair means or malpractice or any misconduct while appearing for the test including giving/receiving help to/from any candidate/outsider during the test will be disqualified. Candidates should be vigilant to ensure that no other candidate can copy/see their answers.
11. The responses (answers) of a candidate will be analyzed with other candidates to detect patterns of similarity of right and wrong answers. If in the analytical procedure adopted in this regard, it is inferred/concluded that the responses have been shared and scores obtained are not genuine/valid, the candidature of the candidate may be cancelled and/or the result withheld.
12. Anyone found to be disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of test contents in any form or any information therein in whole or part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied in the test hall or found to be in unauthorized possession of test content is likely to be prosecuted.
13. The possibility of occurrence of some problem in the administration of the test cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of re-test is at the absolute discretion of test conducting body. Candidates will not have any claim for re-test. Candidates, not willing to move or not willing to participate in the delayed process of test delivery, shall be summarily disqualified from the selection process.
14. No request for change of test centre/venue or date of test shall be entertained.
15. No Travelling Expenses will be paid to any candidate for appearing in the CBT.
