
Sir,

**Sub: The enhanced gratuity (from 10 lacs to 20 lacs) not applicable to the employees of NVS retired from 1.1.2016 to 31.3.2018. Plea to interfere to make applicable to the deprived employees - regarding.**


Sir,

This is in reference to your representation dated 21.3.2020 addressed to the Hon'ble Vice President of India on above mentioned subject.

2. It is to submit that NVS is an autonomous organization under D/o SE&L, MHRD. The orders of Government for Central Government employees are not extendable to the employees of autonomous bodies automatically. Moreover, the employees of NVS being not covered under GPF are also not covered under CCS (Pension Rules) 1972. However after the amendment in Gratuity Act 1972 in the year 2009, the employees of NVS are now covered under the Payment of Gratuity Act 1972.

3. Since the employees of NVS are covered only under the Payment of Gratuity Act 1972 and not under the CCS (Pension Rules) 1972, the revised ceiling of gratuity would be effective from the date prescribed in the notification issued by the Government under the Payment of Gratuity (Amendment) Act, 2018 (copy enclosed) Therefore, enhancement in Gratuity of Rs. 20 lakh for the employees of NVS will be applicable only from 29.3.2018.


