- 3. An earnest money of Rs.4,000/-(Four Thousand Only) should be deposited in the form of a crossed Demand Draft/Banker's Cheque drawn in favour of Pay and Accounts Officer, Ministry of Human Resource Development payable at New Delhi. Payment of earnest Money Deposit in cash or in any other form will not be accepted. The quotations received without the Earnest Money Deposit will be summarily rejected. The earnest money will be liable to be forfeited, if the tenderer withdraws or amend, impairs or derogates from the tender in any respect within the period of validity of his tender.
- 4. The terms and conditions of the said contract are as under :-
- i) The successful tenderer will be required to undertake the 'maintenance ' and other related job works for a period of 12 months w.e.f from the date of award of contract. This can be extended on year to year basis upto three years, depending on the performance of the contractor. The performance of job-work shall be reviewed at the end of every quarter and the Ministry reserves the right to terminate the contract at any time, if the services provided by the contracting firm are found to be unsatisfactory. The decision of the Ministry shall be final and binding on the firm in this regard.

- The work will have to be carried out in the premises of the ii) Ministry, the offices of which are located in Shastri Bhavan, Parliament Street and R.K Puram. The Twin-Set instruments installed at the residential offices of Ministers in the Ministry/Department are also covered under the contract.
- iii) The rates of the following items of works may also be quoted:

Shifting of Beetel twin-set (1+1)

- Fixing of cable (single to five pairs) per meter, if required, for replacement of defective cable or fixing of additional cable at the time of shifting;
- Fixing of channel per meter/feet.
- iv) The contracting firm is required to depute a well-experienced service engineer/mechanic for the maintenance/servicing repair of the instruments concerned. All the complaints/calls should be attended to by the contractor firm on the same day. A report in this regard shall also be submitted along with the bills.

The rates for the maintenance work furnished by you will be valid for the whole period of contract and no upward revision of rates will be allowed during the period of contract under any circumstances. In a nutshell, it shall be responsibility of your firm to carry out the requisite servicing and all sorts of repairs that are very much necessary for the proper maintenance/upkeep of the single telephone throughout the period of contract.
