This Ministry would require Sixteen Buses with seating capacity for 45 persons & above and one mini bus with seating capacity for 25 persons & above from 7.00 AM to 9.00 P.M. on 4<sup>th</sup> and 5<sup>th</sup> September, 2016 in connection with the function of National Award to Teachers, 2015, with the following terms and conditions:

i)

No tender will be accepted after expiry of the schedule date and time i.e. 15<sup>th</sup> June, 2016 upto 5:30 P.M. The sealed Tenders will be opened on 16<sup>th</sup> June, ii) 2016 at 3:30 P.M. in room no. 105-C wing, Shastri Bhavan, New Delhi in the presence of the transporters/agencies who may like to be present.

The rates quoted should be inclusive of all Taxes, Parking Charges, Toll Tax iii) etc., excluding service tax.

- All taxes as applicable will be deducted at source. iv)
- The payment will be released provided performance is found satisfactory. No V) advance/Extra payment will be made.
- In case the price of petroleum/diesel products increase or decrease the rate offered will not be effected. No escalation will be considered except vi) Government levies. Govt. Levies will only be considered on production of original receipt along with the bill.

The Ministry will impose 15% penalty on the transporter or as deem fit for any vii)

of the following reason: a) Misbehaviour of the Bus Driver, non-co-operation during the function.

- b) Late arrival of buses at the pick-up points as per the time schedule given.
- c) Providing of buses of model before 2010 or bad condition.
- d) The Department reserves the right to accept or reject any or all the tender without assigning any reason.
- e) Withdrawal of offer after the opening of the tender shall make whole offer invalid, attracting debar of the agency for all future work in addition to penalty stated at clause No.vii) above.
- f) The decision of the Department will be binding on Transporters in case of any dispute and action with regard to debarment/black list may also be taken against the transporter.
- g) The legal jurisdiction will be the courts of Delhi/New Delhi.
- 2. You are requested to quote your charges inclusive of CNG/diesel for 02 days.
