It is to be mentioned that the vehicles at S.No. 1 to 7 are available for inspection in Shastri Bhawan premises near Central Secretariat Library adjacent to Garbage Yard at Shastri Bhawan, New Delhi.

Firms/persons having clearly identifiable ID (PAN/Driving License/Voter ID Card/Residence Proof) interested in purchase of the above mentioned vehicles are invited to participate in the public auction on the above mentioned date and venue. An EMD of Rs. 15,000/- (Rupees fifteen thousand only) as Demand Draft in the name of Pay & Accounts Office (Education) will have to be deposited on the spot before participating in the auction. The successful bidder will be required to remove the vehicle at his own expense within 3 days after acceptance of his bid and after making the payment of the bid amount as Demand Draft in the name of Pay & Accounts Officer (Education).
