2. It may also be noted that all the above furniture will be as per the specifications given above. All the above furniture items will be of best quality. Further, rates quoted should be inclusive of supply/freight etc. and no extra payment will be made for supply of above items.

3. Only reputed and experienced firms having adequate experience, of at least three years in the relevant field in Govt. Ministries/Departments/Govt. or Semi-Govt. Organizations/PSUs/Corporate Sector etc. and having the requisite competence /capacity to handle jobs relating to furniture items need apply. While submitting the tenders, the intending tendering firms shall have to furnish the Department with proof of experience, valid PAN Number, Sales Tax Number, Service Tax No., VAT No. etc. as per Annexure -I.

4. Duly filled tender should be submitted alongwith a crossed Demand Draft of a value of Rs. 15,000/- (Rupees fifteen thousand only) towards the Earnest Money Deposit(EMD), drawn in favour of PAO(Edu.), Department of Higher Education, Shastri Bhawan, New Delhi. Interested Firms may submit their unconditional rates (in the enclosed Annexure) to the Under Secretary(S&S), Department of Higher Education in a sealed cover. The outer cover should be superscribed "Tender for Providing furniture items in M/o HRD, D/o Higher Education" and should be put in the Tender Box, placed at Information and Facilitation Centre(IFC) of the Department, at Gate no. 6, Shastri Bhawan, New Delhi by 3.00 P.M. on 28.12.2012. The tender will be opened on the same day at 3.30 P.M. on 28.12.2012 in Room No. 123-C, Shastri Bhawan, New Delhi in the presence of the representatives of the firms, if any.

5. The tenders received without EMD in the above manner or incomplete tender in any respect shall be summarily rejected. The EMD shall be returned soon after the finalization of the tender process. However, in the case of the successful tenderer, the



EMD will be returned only after the firm concerned deposits necessary Security Deposit with the Department.

6. The successful tenderer will be required to deposit an amount equivalent to 5% of the tender value towards Security Deposit as performance guarantee, through FDR from any Nationalized Bank, duly pledged in favour of PAO(Edu.), Department of Higher Education, Shastri Bhawan, New Delhi-110001, within two days from the date of acceptance of offer. The Security Deposit is refundable after a period of 6 months on completion of the work.


7. The supply of above furniture items would be made within 25 days from the issue of supply order to the firm.

8. It must be noted that if the items supplied are not as per the specifications and design (at Annexure-II), the same will not be acceptable and no payment will be made to the firm.

9. Overwriting on the tender documents must be avoided, otherwise the quotations are likely to be rejected. The Department reserves the right to accept or reject any tender, in whole or in part thereof without assigning/specifying any reason(s) thereof and the decision of the competent authority in the Department shall be final and binding on the firm. The firm entrusted with the work shall have to carry out the contract at the rates approved by the Department.

10. All the participating firms will ensure that the items are of only reputed and Standard Quality and at any stage it is found that the items supplied are of sub-standard quality/inferior quality, the cost of the item will be recovered from the firm.





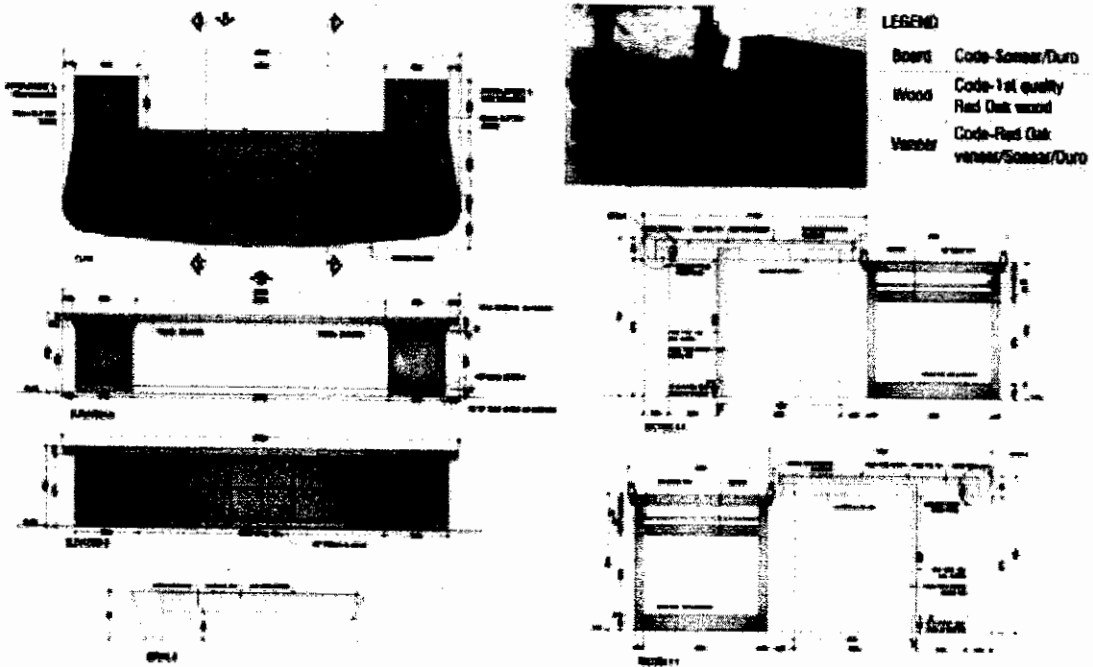

Reference Image for main table and other furniture

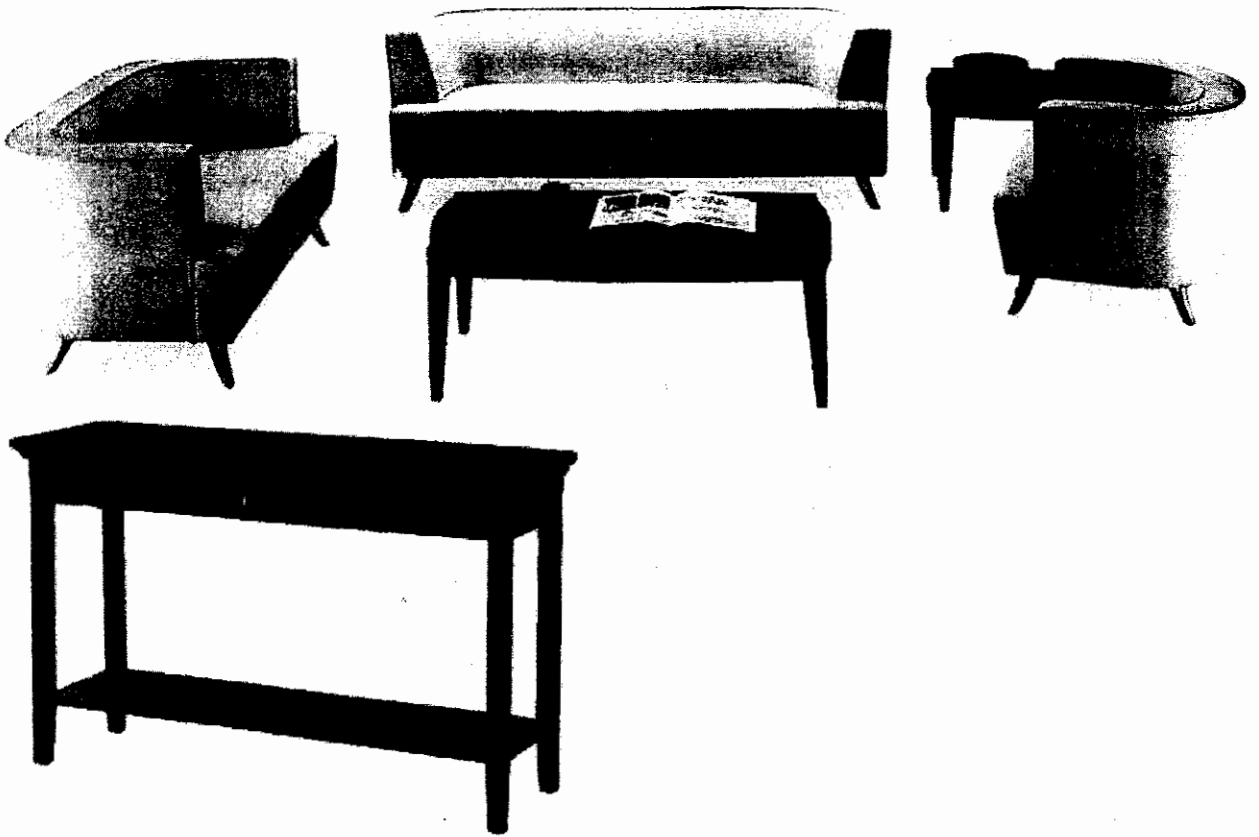


Polish color on wooden furniture to be approved by architect.

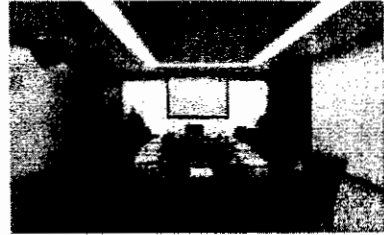
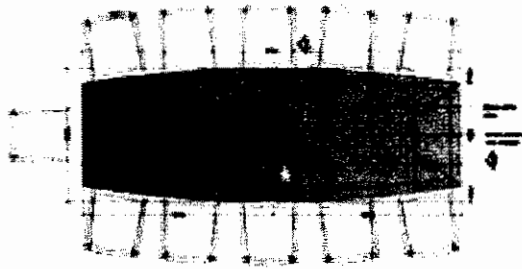
Reference Images for Sofa, Centre Table and console behind sofa

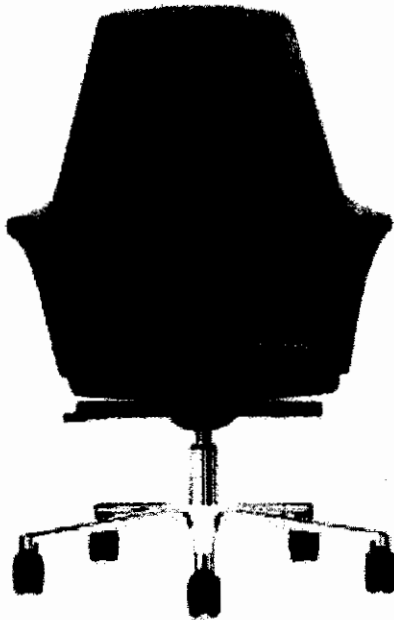
