- 8. In all matters of dispute relating to this Contract, the decision of the competent authority in the Department shall be final and binding upon the agency.

- 10. In case the services of the contracted agency are found un-satisfactory, the services of the agency will be terminated immediately, without any further notice or without assigning any reason and the decision of the competent authority will be binding on the agency.
- 11. Quotations should be accompanied by **earnest money deposit (EMD)** of Rs. **2,000/-(Rupees Two Thousand only)** in the form of Demand Draft of any bank drawn in favour of PAO (Edu) Department of Higher Education, Shastri Bhawan, New Delhi, without which the quotations will not be considered. The earnest money will be returned to all the unsuccessful tenderers after the finalization of the contract. The earnest money will stand forfeited if the successful tenderer withdraws the rates quoted or does not accept the offer or resiles from any conditions of the contract.
- 12. The successful tenderer will be required to furnish security deposit amounting to **Rs.5,000/- (Rupees five thousand only)** within 10 (ten) days from the date of acceptance of tender. The security deposit shall be in the form FDR through any nationalized bank in favour of PAO (Edu), Ministry of Human Resource Development Shastri Bhawan, New Delhi. The security deposit money will be refundable only after the expiry of the contract. The security deposit will be forfeited if during the period of contract your services are found to be unsatisfactory in any respect.
