# Term of Reference: -

- 1. The committees shall register, investigate and dispose off grievances brought before them within three months.
- 2. For the purpose of 1. Above the committee concerned shall, after getting the case investigated through one or more of its members, pass an order by consent of at least two-thirds of its members.

#### D. State Level:

The State Commission for Protection of Child Rights (SCPCR) would act as Grievance Redressal Authority at State Level.

The Appellate Authority for orders passed by each of the committees mentioned above will be the SCPCR whose decision shall be final.
