In exercise of the power conferred under Section—35 (2) of "The Right of Children to Free and Compulsory Education Act, 2009" the Governor, Himachal Pradesh is pleased to order that the Municipal Corporation or Municipal Council or Panchayat Samiti or Nagar Panchayat, or Gram Panchayat or Block Elementary Education Officer or Deputy Director of Elementary Education by whatever name called in the area of the state shall be the local authority for the purpose of section 2(h) of the Act in respect of all elementary schools (primary) upper primary) functioning under their jurisdiction. The roles to be performed by each of the local authority have been defined as follows:-
